# Priority Needs: Summary

## 1. Ready Children

All children have the social, emotional, physical and intellectual skills they need in order to succeed in kindergarten and beyond.

## 2. Ready Families

All families have access to the resources they need in order to provide their children with secure and supportive relationships and environments, promote physical and mental health, and foster curiosity and a love of reading and learning.

# 3. Ready Early Care & Education Programs and Professionals

All early care and education professionals have access to the resources they need in order to deliver quality early care and education services that are responsive to cultural values and individual differences, that promote equity and diversity, and support families and essential and respected partners in promoting the optimal development of our children.

#### 4. Ready Communities and Systems

Our entire community realizes and acknowledges the importance of school readiness and works with us and other essential community partners to make Clarendon County a place where our preschool children thrive.

# Objectives

## **STRATEGY 1.1**

Expand, create and foster opportunities for parents to learn more about early childhood development, school readiness and what they can and need to do in order to contribute to the readiness of their children.

# **STRATEGY 1.2**

Expand proven, evidence-based parent education and support programs so that more parents can participate.

# GOAL(S)

 By 2026, CCFS will have increased the number of families with preschool children served in the Parents As Teachers program (and potentially other parent and education and support programs) by 21%.

# **Objective 2: Preschool children have literacy-rich home environments.**

# **STRATEGY 2.1**

Expand existing programs and strategies that provide free, quality, and age-appropriate books and other early literacy materials to families with preschool children at no cost to them.

## **STRATEGY 2.2**

Identify and utilize other opportunities to acquire and distribute free, quality, and age-appropriate books to preschool children.

#### **SMART GOAL(S)**

 By 2026, CCFS will have increased the number of Clarendon County's preschool children participating in the Imagination Library and similar early literacy programs by 13%.

1. By 2026, CCFS will have increased the number of childcare scholarships available to assist parents by 10%.

# **STRATEGY 3.2**

Increase investments in early care and education programs to improve their quality.

# **SMART GOAL(S)**

1. By 2026, 25% of Clarendon County's childcare providers will have successfully completed one or more activities and implemented one or more strategies to enhance the quality of their programs and services.

Implement and expand research-based programs to help children smoothly and successfully transition from 4-K to 5-K.

## **SMART GOAL(S)**

1. CCFS will increase the number of Clarendon County's children participating in Countdown to Kindergarten by 15%.

# **STRATEGY 6.1**

Engage early care and education programs and providers in training, quality enhancement, technical assistance and coaching to equip them with the skills and resources they need in order to promote positive child development.

#### **STRATEGY 6.2**

Assist and support early care and education professionals in establishing an active and ongoing support network/group.

# **SMART GOAL(S)**

1. By 2026, the number of children under age 6 who benefit from CCFS's work with Clarendon County's early care and education professionals will increase by 18%.

By 2026, CCFS will have developed and enhanced relationships with agencies and organizations within the community by 100%.
