The meeting began at 3:36 p.m.

Mr. Morley welcomed David Lisk, York County First Steps Executive Director, and Dorothy Priester, Cherokee County First Steps Executive Director, to their first in-person council meeting. He asked for a motion to adopt the agenda. Mr. McBride provided the motion. Dr. Williams provided a second and the motion was unanimously approved.

Mr. Morley asked for a motion to approve the August 17, 2023 minutes. Ms. Neeley provided the motion. Mr. Pryor provided the second and the motion was unanimously approved.

Ms. Oliver introduced Charles Appleby, Advisor to the Coordinating Council for Workforce Development, who went over the statewide Educational Workforce Development Act and presented the Unified State Plan for the council.

Ms. Gillum reported on the interagency collaboration committee.

Ms. Mjartan reported on activities of the ECAC. She shared First5SC data and website metrics. She shared that there will be a launch for a cohort of six to eight local school districts and two Head Start providers later this month. She also shared the nationwide reach that First5 has had while SC serves as a model to other states. Lastly, she provided information on the annual board meeting and the end of year celebration that are being held on December 6<sup>th</sup> as well as the Summit on Early Childhood that is being held on December 7<sup>th</sup>.

Mr. Morley asked for a motion to adjourn the meeting. Mr. Pryor provided the motion, seconded by Mr. Lisk, and unanimously approved. The meeting ended at 4:15 pm.



# Report on Early Childhood Advisory Council Activities December 6, 2023

## ECAC

- The SC Summit on Early Childhood is Thursday, December 7. The venue is at capacity. More than 450 people are registered, and 26 tables/exhibits are featured at the event.
  - A preconference virtual event will be offered the afternoon of December 6, from 3:00 4:30 PM. This event is free and offered as a way to include parents who might not be able to participate in a full-day, in-person event.
- ECAC staff are updating Birth through Five Plan data to share with ECAC and with the public at large. These updates will be released in the new year.

### SC Early Childhood Integrated Data System

The Data Governance Coordinator and the Director of Research and Strategy attended a grant sponsored workshop for ECIDS Data Governance in Phoenix, AZ with 11 other states. The information will be used to refine the SC data governance plan as the SC Department of Education completes the Early Learning Extension by 2024.

- Training for providers began October 30 and will continue through February for a total of 11 planned trainings. Trainings in October and November were well received, with the follow-up campaign to attendees exceeding industry standards by almost 100% for opening and clicking links contained in the emails.

### Family Voice Council (FVC)

Currently, 18 parents and caregivers represent the FVC. Six member terms end 12/31/23, with one candidate currently in the onboarding process. Recruitment is underway for the 7 seats that will be open in January 2024.

Members and alum of the Family Voice Council will be attending the summit on December 7, 2023. The Family Voice Council led content curation for the 2023 SC Summit on Early Childhood, and six members and alum will open the day with a Family Voice Spotlight.

#### Grants

- Alliance for Early Success
  - Three staff members attended the annual Alliance summit, CONNECT, in Charlotte, NC in October. The summit connects grantees from across the country with national experts and researchers to exchange ideas and build connections they can leverage as they pursue strong state early childhood policy.
  - ECAC staff met with multiple national TA providers, such as The Hunt Institute, the Committee for Economic Development, True North, and Council for a Strong America.
- Preschool Development Grant (PDG B5)
  - South Carolina, along with other PDG B5 grantees were awarded supplemental funds to enhance and build on their planning work. No cost extensions may be requested through December 2024. South Carolina will request that extension.
    - A small percentage of those funds will be used for First Five SC technical support.
  - Grants.gov forecasted that up to 10 PDG B5 renewal grants will be awarded in 2024. South Carolina is eligible to apply.
- Pritzker Children's Initiative Support State and Local Leaders to Build Comprehensive Early Childhood System Portals
  - A video to introduce the First Five SC portal was completed in November. It will be posted on the website following its view at the ECAC meeting and its "premier" at the SC Summit.
  - Since the last ECAC meeting the First Five SC team made three presentations: BUILD Conference (in person); convening of human services leaders from western states (virtual); and presentation to community of practice convened by SRI (in person).
  - Hawaii and San Diego are scheduling meetings in January.
