Priority Needs: Summary

Through a series of community convenings, a needs assessment and asset mapping process, the following needs were prioritized for Jasper County. See our full needs assessment<u>here</u>.

1. Kindergarten Readiness

Ensure that children arrive at kindergarten with the healthy, with the skills and physical well-being necessary to ensure early school success.

2. Single Parent Households & Teen Parents

Target services and supports that are most effective in reducing disparities to close equity gaps ensuring a fair chance for every child.

3. Community Convener and Portal of Children's Services

Explore and develop the role as a connecter and conduit of services and referrals for the needs of young children, their families, and service providers.

1. By Summer 2024, implement Countdown to Kindergarten strategy at two public elementary schools, serving 20 rising kindergarteners

STRATEGY 2.1

Prioritize service delivery for families and children most at-risk of early school failure including single-parent families, teen parents, families experiencing homelessness, dual-language learners, and children with disabilities.

SMART GOAL – Parents As Teachers

 By FY26, increase the number of high-risk families or children served through Parents As Teachers program by 15%

STRATEGY 2.2

Intentionally strengthen the cultural competence of Partnership programs and staff by partnering with immigrant-serving and other diverse community-based organizations to coordinate services, identify providers and refer families; Promote inclusivity, equity and accessibility as valued attributes in hiring and staff development

SMART GOAL – Parents As Teachers

1. By FY26, provide current and newly hired partnership staff "Spanish in the Workplace" training to increase cultural and linguistic competence in service delivery.

Objective Three: Support a coordinated, familycentered early childhood system

STRATEGY 3.1

Further develop the role that Partnership plays in serving a community "hub" for early childhood services, ensuring community services reach families most-in-need and who would most benefit.

SMART GOAL(S)

 Each April, convene one community forum comprised of community stakeholders, service providers, parents, ECE providers for ongoing community needs and resource assessment.

Overarching Measure(s) of Success

By FY26, the percentage of children in need who are directly served by Jasper County First Steps high intensity programs will increase from 6% to 8%.
