The meeting was called to order with a quorum present at 2:06 p.m.

Reporting for the Strategic Planning and Evaluation Committee, Dr. Chelsea Richard, Chief of Strategy and Research, shared that the focus of the 2026 Child Trends external program evaluation will be on child care technical assistance.

Reporting for the Finance and Administration Committee, Chief of Administration Mark Barnes reported that agency finances are track. A new financial management system is replacing the current system, and SC First Steps is preparing a single audit of its ESSER funding.

Government Liaison Kaitlyn Richards provided a legislative report. The House has passed its budget for next year, and Senate Finance Committee is sending its budget to the floor for a vote next week. Both budget items for First Steps are similar, but the House's version has \$750,000 less for nonrecurring Innovation Investments. Paid extended leave for state employees is being debated.

A special guest from the SC Education Oversight Committee, Dr. Jenny May, provided findings from the Kindergarten Readiness Assessment on four-year-old children participating in CERDEP pre-k. Results showed a dip in demonstrating readiness for all students.

Agency Director Ann Vandervliet shared in her report information on upcoming agency events, an update on First Steps 4K 2025-2026 school year enrollment, and a system-building proposal for a three-county pilot to provide a continuum of services to move the needle on kindergarten readiness.

Dr. Richard provided an overview of the last five years of First Steps as the agency looks to create its strategic plan for the next five years. She shared next steps on public comment and plan approval.

Ms. Williams made a motion to adjourn, seconded by Mr. McBride. The motion was unanimously approved. The meeting was adjourned at 3:20 p.m. by Chairman Morley.

## For Program and Grants Committee Approval, June 2025

## **Background**

Starting with the FY2022-23 fiscal year, SC First Steps has received funding from the General Assembly for targeted and competitive grants to local partnerships. For FY2026, the General Assembly has also approved additional, one-time funding specifically targeting multi-county partnerships and/or with partner agencies that have related funding. These funding opportunities are in addition to the annual formula allocation.

## **Formula (Annual State Allocation)**

The Formula Allocation is the annual amount each partnership receives through the approved allocation model based on the American Community Survey population estimates for each county. Formula allocation submissions were reviewed for compliance to SC State Law, Program and Operational guidelines, Finance Operational guidelines, and minimum qualifications.

## READY (Resources for Early Acceleration and Development in Youth)

Recurring funding of \$3 million annually in General Funds, of which at least 97% (\$2.91 million) is to be awarded by the SC First Steps Board of Trustees to local partnerships through competitive and targeted grants. The purpose of these funds is to prioritize evidence-based programs for children birth through age three, who live in rural communities and in communities where kindergarten readiness scores are consistently below the state rate. No more than 10% of appropriated READY funds may be distributed to any one county. Since inception, SC First Steps has issued \$7,804,830 in READY funding to local partnerships to strengthen infrastructure and capacity; establish, sustain, and expand evidence-based programs; and test innovative approaches to serving young children and families.

For FY26, SC First Steps has a total of \$3,885,170.17 in available READY funding (\$2,910,000 in FY26 funding, \$925,169 in carryforward funding, and \$50,000 in recaptured funding) with which to: a) fund previously approved READY awards; and b) award new READY grants. SC First Steps will be awarding \$1.2 million less READY funding in FY26 than was awarded in FY25, due to having a smaller balance of carryforward funding available.

There are three categories of previous, multi-year READY grants that are entering their final year of funding in FY26: Infrastructure and Capacity, Child Care Technical Assistance

Programs, and the Carolina Collaborative for Early Childhood Innovation (CC4ECI). Collectively, these previously awarded READY grants total \$786,825.92, leaving \$3,098,344.25 available for new READY awards to be approved by the Board of Trustees. Additional information on previous awards is included in Table 1.

## Innovation Investment Funding (NEW)

**\$2,500,000** in one-time (non-recurring) funding to incentivize counties ready to embrace more formal partnerships through blended funding with one or more other local partnerships and/or with partner agencies that have related funding. Funding will be competitive with no geographic cap and will encourage more advanced collaboration between clusters of counties.

Requests for Innovation Investments must clearly define how partners will share costs, reduce administrative burden and increase reach for at least one evidence based and high intensity program or service. Strategies for this funding must serve a minimum of 50 additional children, parents or families (whatever is the most appropriate unit of measure). The proposed service and/or program must also have strong technical assistance available at the state and/or national level.

## **Application and Selection Process**

Local partnerships applied for FY26 funding via the **Comprehensive Grant Application**, through which they were to request all state funding from SC First Steps: Formula funding, READY funding, and Innovation Investment funding. Each local partnership submitted a narrative and proposed budget that described its local early childhood system, current level of impact, operational capacity, and FY26 funding request. Each application was scored by a three-person reviewer panel comprised of SC First Steps staff from across the organization. Local partnerships were also assigned compliance scores based on their past program and fiscal performance.

Within the grant application local partnerships were to align their request with the following funding priorities:

- Potential to impact demonstrated school readiness on SC's kindergarten readiness assessment
- · Potential to impact both child and family in a positive and measurable way
- Capacity for successful implementation.

- Potential to reach the highest number of children in the most meaningful way (evidence based, high intensity, focused and collaborative selection and planning).
- Degree to which a particular program and service is likely to be maintained, sustained due to cost and impact over time.
- Intent to contribute to a connected, relationship based, and family focused local and/or regional early care and education system.

Following reviewer and compliance scoring, Program Officers contacted their local partnerships with questions and points of clarification from the review team.

A total of 38 local partnerships requested new READY funding. One READY application was late and deemed ineligible. The 37 eligible applications for new READY funding totaled \$4,183,413 in requests, which is \$1,085,069.26 more than the amount of new READY funding available to award. To make these difficult funding decisions, the staff team prioritized funding to local partnerships whose READY grants ended June 30, 2025 and attempted to fund those partnerships to at least the level of their FY25 funding. Requests to fund Parents as Teachers affiliate support costs were eliminated, as were funding requests that did not have a direct impact on number of clients served. Nearly all local partnerships recommended for READY funding are receiving less than they requested. Four of the five local partnerships not recommended for funding requested small amounts for PAT affiliate fees, and the fifth is postponing their request until next year.

Marion's READY funding request is to be determined, pending requests for additional information.

Ten local partnerships submitted Innovation Investment requests, totaling \$2,190,290. Each Innovation request was reviewed in-depth by both Local Partnership team members and senior staff, followed by individual consultations to refine the project design and budget.

## **Summary of Innovation Investment Proposals**

## **Allendale and Hampton Counties**

**Program(s)**: Enhanced Early Education-Onsite Tutoring and Home Instruction for Parents of Preschool Youngsters (HIPPY)

**Description**: Allendale and Hampton counties will pilot a revised implementation of the HIPPY program, combining administrative costs and supporting new staff to serve at least 50 families in the two counties (HIPPY request: \$272,400).

Allendale is also planning to expand their Enhanced Early Education- Onsite Tutoring program in collaboration with the school district to serve at least 40 additional families (Enhanced Early Ed request: \$55,000).

#### **Greenville and Pickens Counties**

Program(s): Nurse Family Partnership (NFP)

**Description:** Greenville and Pickens will partner with Prisma-Upstate to support the expansion of NFP in Greenville and Pickens Counties. Two nurses will serve an additional 50 families.

## Kershaw, Lee, and Sumter Counties

Program(s): Parents as Teachers (PAT) and Strengthening Families

**Description:** In this Tri-county partnership, parenting programs will be shared across the 3 counties, with Kershaw and Sumter counties supporting additional PAT implementation in Lee County and Lee County supporting implementation of Strengthening Families in Kershaw and Sumter Counties. The partnership will allow for at least 50 additional families to be served with PAT and 30 additional families to be served with Strengthening Families.

## **Berkeley and Charleston Counties**

**Program(s)**: Early Education Program Support, Triple P, and Parents as Teachers (PAT) Description: Berkeley and Charleston counties will partner on supporting four (4), 3-year-old kindergarten (3K) classrooms (2 in each county) with enhanced teaching strategies, environmental and developmental assessments, and additional supports for children and families (3K enhancement requested amount: \$375,032). They will also offer Positive Parenting Program (Triple P) Level 4 to families with children in the participating classrooms. The collaboration will also include providing PAT to at least 50 additional families, including those with children enrolled in the 3K classroom (PAT request: \$430,000).

## **Program Description**

HIPPY (Home Instruction for Parents of Preschool Youngsters) is a home visiting program that supports parents in their role as a child's first teacher. Every week for 30 weeks, a trained HIPPY Home Visitor will conduct in person role play visits with families of young children. Visits are guided by curriculum designed to equip parents with the skills and tools necessary to succeed in their role as their child's first teacher.

The First Steps HIPPY program is designed for 3- and 4-year-old children. It is beneficial for low-income families, parents and caregivers with limited education, families with a history of child abuse and/or involvement with the child welfare system, and families experiencing language barriers.

Local partnerships funding HIPPY shall ensure full compliance with national model guidelines. Fidelity of implementation in SC includes meeting requirement documented in the HIPPY US Manual of Accreditation Standards for Quality HIPPY Programs.

### Reason for Changes

The loss of AmeriCorps funding impacts how the HIPPY program is implemented in South Carolina. Multiple aspects of HIPPY oversight and supervision was accomplished through the First Steps State Office. Re-launching HIPPY gives First Steps to function like other evidence-based parenting programs at the Local Partnership level. The revised guidelines reflect the change in service delivery and maintains fidelity to the HIPPY US model. In addition, the changes set HIPPY in South Carolina up for growth and expansion.

## Summary of Changes

- The staff position of Parent Educator changed to Home Visitor.
- Language specific to recruiting home visitors implement HIPPY services revised.
- Role of the HIPPY Supervisor/Coordinator revised to meet HIPPY US standards and guidelines at the local level.
- Revised the standardized assessment tool used to measure school readiness due to broadening recruitment beyond First Steps 4K.
  - The standardized assessment tool is yet to be determined. The parenting team is researching the tools recommended by HIPPY US.

Saluda County First Steps will be implementing the Childcare Scholarship Program (Code 703) for FY26 and has requested five scholarships for Saluda residents to start this new program.

Saluda County First Steps Executive Director, Kim Chariker, has a personal interest in a provider located in Saluda; therefore, to avoid any conflict of interest, ED Kim Chariker, will not be part of the application process for the scholarships awarded. Saluda First Steps hired Hortencia Acevedao as program administrator to manage all aspects of the Childcare Scholarship application process.

Applicants must have a child age birth through kindergarten entry and have at least one risk factor (two risk factors are required for 60% of the scholarship applicants) at the time of enrollment to be eligible for the program, as required in the FY26 Program and Operational Guidelines of South Carolina First Steps. Also, applicants must enroll in the Saluda County First Steps Positive Parenting Program (Code 222) within the current fiscal year to be eligible to receive childcare scholarships.

Saluda First Steps will provide a Childcare Scholarship application orientation and training on the benefits of high-quality childcare for all applications. As an SC Endeavors Certified Trainer, ED Kim Chariker, may assist Hortencia Acevedo at the orientation and training. Completed applications will be submitted to Hortencia Acevedao who will review the applications, as well as the risk factor forms. Mrs. Acevedo will evaluate applications, categorize applications in the order in which they are received, and maintain a waiting list.

Hortencia Acevedo will forward pre-screened applications to SCDSS for Child Care Scholarship Program approval. The SCDSS-required scholarship application will be completed. SCDSS eligibility determination will be returned to the local partnership to Hortencia Acevedo. Mrs. Acevedo will inform applicant parents of the status of their applications and notify parents of their award once approved by SCDSS. Parents will select the qualified childcare provider of their choice that accepts Child Care Scholarship Program vouchers. Applicants will be directed to the online list of qualified providers.

Hortencia Acevedo will complete the KITS Data System training in order to input data in the KITS Data System for Scholarships (703) and ASQ assessments scoring. She will also be responsible for getting the required screenings to the parents and/or their selected childcare center.

#### Approval of 2023 990 for SC First Steps

Required Action Item: Approval for the 2023 990 for SC First Steps

Josh Garvin, CPA, Principle for Manley Garvin LLC., presented the draft 990 for SC First Steps. He reviewed the document and discussed several points. He mentioned the 990 reflects the financial information presented in the financial statements already reviewed by the Board for FY 2024. He provided that the format is different but the numbers are the same. After the review, Jacque Curtin motioned to approve the 2023 990 form, which was seconded by Dave Morley and then passed. The motion will be included in the consent agenda for the upcoming board meeting.

**Motion:** To approve the draft 990 Form for SC First Steps for tax year 2023, as submitted by Manley Garvin and recommended by staff, and for the staff to make any necessary grammatical or other minor changes.

#### **Update on Aiken Corrective Action Plan**

Ann was not able to be at the meeting but Mark mentioned that she had scheduled meetings with them over the next few days and would provide an update to the board after that. She will provide written recommendations at that point.

#### **State Office Staff Updates**

**Financial Report:** Mr. Barnes reviewed the monthly financial reports. The agency is in good financial condition. This discussion also included the amount spent to date and he reviewed the donations to date for this year.

**ESSER Expenditure Review:** Mr. Barnes mentioned that state office staff were working with a number of local partnerships related to concerns identified with allowable expenses with their ESSER Funds. These are federal funds that have very specific restrictions. He talked about actions that have been taken to correct these to ensure that SC First Steps Single Audit, which will take place this year, would

be clean. One local partnership has not been as responsive as they should be to clearing up any deficiencies.

**Financial Management System Update:** SC First Steps is working to replace the financial management system for the local partnerships. It has been determined that we will need to do an emergency procurement to replace the current system. We have been reviewing options and doing extensive research into the capabilities of three different systems. We have selected the one we believe that best meets our needs and will be proceeding on to working out contractual arrangements with them. We have extended the agreement with Blackbaud to allow for enough transition time to do complete this. We hope to start the new system prior to the new fiscal year, but this will depend on how quickly we can get the agreements signed.

#### **Local Partnership Update**

**AmeriCorps Grant:** Mr. Barnes shared that First Steps had their AmeriCorps grant canceled by the federal government. This was along with most of the grantees in SC for FY 2024-25. The grant was canceled even though we were operating the largest and one of the most successful grants in the state.

**KITS:** The new data system is planned to go live for the local partnerships the summer, with 4K planned over the next year.

**4K Update:** The 4K program is on track to increase about 9% in student enrollment this year.

With no further business to discuss for the committee, the meeting was adjourned at 10:00 a.m.






## **Legislative Committee Report**

Senator Greg Hembree Thursday, June 19, 2025

The Budget Conference Committee approved their recommendation on Wednesday, May 21<sup>st</sup>. On Wednesday, May 28<sup>th</sup>, the General Assembly ratified the 2025-2026 General Appropriations Bill and sent it to the Governor's desk. Governor McMaster signed the budget with line-item vetoes on June 4th.

First Steps will receive over \$5.7 million in new state funds this year. The following allocations were included:

- Unfunded Personnel Cost Increases (EIA): \$192,108 recurring
- Recruitment and Retention Costs: \$264,401 recurring
- Innovation Investments: \$2,500,000 non-recurring
- Full Day 4K (CERDEP): \$2,777,120 recurring

Proviso Revision: 4K Updates, First Steps & SDE shall annually share waiting lists.

Proviso Deletion: SDE-First Steps Division

#### 1. First Steps 4K

- Forty seven new child care providers (including six A+ sites) have been recruited to serve an additional 500 students.
- 3,226 applications have been reviewe and approved for school year 25-26. Last year, we served 4,119 children.
- CLASS observer certification has been completed by our 4K managers and coaches.
   ABC Quality, Child Care Resource & Referral, and SC Endeavors (31 total). Over the next month, all participants will the take the assessor reliability test.
- The SC General Assembly approved an additional investment in 4K (\$2.7M recurring) to support continued expansion.
- 4K leadership has met with the Education Oversight Committee and the SC Department
  of Education to ensure collaborative implementation of the recently approved Proviso
  that will require local school districts to share their 4K wait lists with SC First Steps no
  later than Sept. 1 each year

### 2. Local Partnerships

- A two day, in person training was provided for Local Partnership Boards and their executive directors June 4-5. Training topics included: introduction to the new financial management system, community needs assessments and strategic planning, systems building and financial planning.
- Ten local partnerships submitted *Innovation Investment* requests, totaling \$1,829,306. Collaboration between *two* or more counties to reduce administrative burden and increase the number of children served by evidence based AND high intensity services. Criteria included:
  - The collaboration must yield a minimum of 50 new children or families served.
  - Funding is competitive with no geographic cap.
  - Applicants included: Allendale and Hampton Counties (\$167,200) for Home Instruction for Parents of Preschool Youngsters (HIPPY) pilot; Greenville and Pickens Counties (\$200,000) for Nurse Family Partnership (NFP) Expansion; Kershaw, Lee, and Sumter Counties (\$496,136) for Parents as Teachers and Strengthening Families Expansion; Berkeley and Charleston Counties (\$1,124,799)

for Program(s): Early Education Program Support, Triple P, and Parents as teachers (PAT).

• The *Innovation Investments* combined have the potential to serve at least 276 new children with an evidence based and high intensity program.

### 3. Early Childhood Systems Building

 Department of Education's OELL and OSES, DPH WIC, Help Me Grow, SC DDSN, SC Thrive, ParentChild+, and First Steps have signed the addendum for publication of RFA's Palmetto Drive to Five dashboard. The Early Childhood Integrated Data System (ECIDS) team is currently awaiting the signed final addendums from our partners at Head Start, Children's Trust, DSS Scholarships, and DHHS Medicaid.

Ms. Priester expressed that the local partnership representatives would like to find ways to better serve on the ECAC. Mr. Lisk shared a series of questions to consider: how can we cast a wider net to reach more children, and how do we inform parents of other options? Ms. Vandervliet suggested that either a Local Perspective item or a topic for deeper discussion be added to future agendas.

Mr. McBride asked about mobile access First Five SC. Ms. Wingo confirmed that parents are saying that First Five SC was useful for WIC clients. Ms. Williams suggested SC Parents as a parent resource.

Mr. Lisk made a motion to adjourn the meeting, seconded by Mr. Wooten. The motion was unanimously approved.

The meeting adjourned at 4:02 p.m.

**Welcome:** ICC Chair Amber Gillum convened the meeting at SC First Steps.

SC Birth through Five Plan: 2025 Progress Report: Karen Oliver proposed reviewed agreed upon steps to produce the Birth through Five Plan 2025 Report. ECAC/ICC partners would share early childhood data, 2025-2026 budget and 2024-2025 accountability in September for compilation. ICC and ECAC partners would share reports as they are submitted to the legislature. Amber Gillum proposed that if reports are prepared in phases, the data and information relating to early childhood could be sent in advance. She also proposed that if more detailed information is available through other reports and sources, that information would be useful to share as well. ECAC staff would use data to identify priorities information consultation with ICC. ICC will receive a draft report for review in November. ECAC will receive the report at its December meeting. Contents will include 2024-2025 achievements, and ECAC priorities for 2025-2026.

**Discussion/Feedback: First Steps Strategic Plan:** Ann Vandervliet reviewed the proposed First Steps 2025 strategic plan with ICC. She asked if important tactics and measures were missing. Feedback from this discussion may inform the final draft of the First Steps Strategic Pla. The group discussed the value of including data relating to:

- Nutritional services and uptake
- The work of the Pediatric Advisory Committee, formerly the Child Well-being Coalition
- Progress of the developmental registry solicited by Department of Public Health
- · Service, uptake and open slots for families in home visiting program

**Strengthening SC's Early Childhood System:** Discussion from the strategic plan led to deeper discussion about the larger, early childhood system. Discussion included:

- Waitlists and the Fast Track program in BabyNet. Jennifer Buster will follow up with additional data about the program.
- Child care access continues to be a challenge.
- SC Infant Mental Health Association (SCIMHA) and SC Inclusion Collaborative attend to
  coaching and consultation regarding behaviors and special needs in child care settings. There
  was discussion about value of meeting with these organizations to understand how special
  needs and behaviors, or lack of resources and training to attend to these needs, impacts
  workforce and turnover.
- Public awareness about early childhood, services and supports is important. How are partners measuring public awareness? Many partners use newsletter opens, and webpage clicks as proxy as indicators.
  - Second Street quizzes were noted as a resource. Salandra Bowman, ETV, offered to work with partners, perhaps through Communications Roundtable, to support this work.
  - There was general consensus that we could do more to cross promote early childhood work and information.

## SC Early Childhood Advisory Council: Staff Report

Presented June 19, 2025

#### 1. Increase Utilization of SC's Early Childhood Resources and Services

#### A. First Five SC (on-line screener for 40+ publicly funded programs)

- An automated messaging system was launched June 3. Surveys will be sent to
  active users to learn more about portal visitors who complete screens and visitors
  who do not. From June 3- June 10, 100 people received texts or emails. Among
  those 100 people, only 23 completed the screener. First Five staff will have the
  opportunity to follow up with both completers and non-completers to learn what
  supports are needed in completing the screener and the application.
- An internal evaluation of First Five for SC is in development. Listening sessions are
  planned through August. The listening sessions, surveys delivered through the
  messaging system, and website use will provide rich data about what parents need
  and want when they are looking for programs and services.

#### **B.** Pre-K Enrollment Day

On April 4, partners shared a single graphic and message encouraging parents of 4-year-olds to check eligibility and enroll their child in no-cost preschool. The message was posted by four school districts, 13 First Steps 4K centers, ABC Quality, SC Child Care Resource and Referral, and SC Department of Social Services. Additionally, several ECAC agency partners, Children's Trust of SC, SC Department of Health and Human Services, SC Department of Public Health also shared the message.

### C. Ready for Kindergarten

- Ready for Kindergarten Live took place Friday, April 25. More than 130 people participated in the free virtual event to learn more on kindergarten readiness.
- 33,000 Ready for Kindergarten magazines, updated for 2025, were distributed.
   Magazines were distributed through public school CERDEP programs, First Steps 4K
   CERDEP classrooms, Head Start centers, PASOs, and members of the statewide
   Ready for Kindergarten Transitions Committee. The magazines were published in both English and Spanish.

#### D. Palmetto Pre-K Keep Jammin'

On May 16, more than 160 teachers and supporters of 4-year-olds attended a free, one-hour deeper-look into a selected topic from the Spring Palmetto Pre-K Jamboree held in March. Survey respondents enjoyed the session and appreciated having the resources for their classroom.

## 2. Support Collaboration within SC's Early Childhood System

## A. Early Childhood Integrated Data System (ECIDS)

Molly Tuck, Strategic Data Fellow, has begun work on her Strategic Data Project (SDP), a capstone project required of the fellowship. Tuck's proposed capstone will create use case applications that analyze longitudinal data from the SC ECIDS program to answer one of the key questions under the data governance framework: *Are those enrolled in early childhood programs on track to succeed?* Her first use case intends to study how different combinations of early childhood services help to predict student attendance and KRA outcomes. This information will allow policymakers and program leaders to better understand what works for who and in what contexts. Tuck will share findings with the ECAC in the coming months.

Background about SDP: The SDP Fellowship is an intensive capacity-building program that selects and places data strategists in education agencies so they may have an immediate impact on policy decisions that affect student outcomes. Based at the Center for Education Policy Research at Harvard University, the fellowship includes extensive training in measurement and analysis, leadership and change management, and education policy. The program leverages SDP's extensive network of experts, faculty, and more than 500 fellows across nearly 300 partner organizations.

### B. Landscape Analysis

In South Carolina there are a number of initiatives or work groups dedicated to one or more factors impacting young children and their families. These groups, as well as programs within state agencies, produce plans and make reports relating to their spheres of influence. To understand the depth and breadth of this work, Emma Matzko, ECAC VISTA, and Cortni Jones, Health Care Assistant, have undertaken a landscape analysis. The purpose of the analysis is to inventory the work in South Carolina, highlight where services for young children and their families intersect, and identify gaps or opportunities for more collaborative engagement.

A total of 46 plans and reports were identified, with 19 focused on Early Education and Development, four on Family and Community, 17 on Health and Wellbeing, and 6 grouped as another area of interest. Key next steps include reviewing, analyzing, and synthesizing report and initiative data, then sharing findings with ICC and ECAC partners. These findings may inform efforts to improve and enhance a more strategically aligned network.
