Essential Functions	<ul> <li>Host outreach activities, such as partnering with other organizations, attending community events, giving informational presentations at universities, clubs, or civic groups to promote FS4K, ECAC, and Local First Steps Partnerships.</li> <li>Create graphic designs, social media materials, flyers, etc. to promote local services and programs.</li> <li>Conduct calls, home visits, and/or virtual meetings to families to give them access to services.</li> <li>Plan and host community meetings (in person or virtual) giving partner organizations needed resources and information about FS4K, ECAC, and Local First Steps Partnerships working under SC First Steps mission and vision.</li> <li>Help families to find services by making referrals that align with identified needs.</li> <li>Manage and maintain good professional relations with families.</li> <li>Ensure the completion of progress notes and other case record notes on time.</li> <li>Support development and maintenance of client records and program documentation.</li> <li>Oversee quality of care complying to contract requirements for contacting families by phone, letter, and conducting home/residential visits.</li> </ul>
