Acknowledgments

The Edgefield County First Steps Needs and Resources Assessment process for 2023 began in January 2023 with surveys that were distributed to community partners and parents with young children.

These survey results were tabulated and a report was created. Additional sources were utilized for data reports, including KidsCount, County Health Rankings and Roadmaps from the University of Wisconsin Population Health Institute, the South Carolina Department of Social Services, South Carolina DHEC Vital Records, the South Carolina Education Oversight Committee, and the American Community Survey 5-Year Estimates (2016-2020).

Two community meetings were held in February 2023 with participants attending representing the local school district, local child care providers, Early Head Start, faith community, Adult Education, Family Literacy, local charter school, law enforcement, mental health, and local non-profit organizations. During the first meeting, the attendees reviewed data relevant to young children and their families and brainstormed the vision and values of an early childhood system where all children reach their highest potential.

During the second meeting, the attendees spent time mapping the county resources/assets and identifying needs of the community. The meeting concluded with the group discussing the gaps in the resources.

Edgefield County First Steps wants to acknowledge those who completed surveys as well as the attendees at the two community meetings. All contributions were invaluable as we proceed with the completion of our needs and resources assessment.

28.6 % of births occur with less than adequate prenatal care

12% of births are to mothers with less than high school education

62% of births are to mothers on Medicaid

7% of births are to mothers under 20 years old

11.5% of births are pre-term (less than 37 weeks)

5.7% of births are low birthweight (less than 2500 grams)



Priority One: Increase Community Awareness of Available Resources

35% of Parents and 36% of Community Partners state that Resources in our Community are Hard to Locate, Cannot Locate, or are Unsure of How to Locate

Priority Two: Provide Opportunities for Parent Education and Support

84% of Community Partners state that parents needing parenting skills are one of the top 3 reasons why children are not ready for school.

Additional information from the Edgefield County First Steps Needs Assessment included data showing that nearly 30% of parents and over 60% of community partners would like to see Edgefield County First Steps offer parenting programs in the community.



Priority Three: Quality and Affordable Child Care

The three licensed child care centers (apart from Early Head Start/Head Start) in Edgefield County are either still pending their ABC rating, or are rated as a C level.

75% of parents rate the cost of child care in Edgefield County as somewhat high or high

57% of parents responded they would like affordable quality child care to be a priority for Edgefield County First Steps
