FY23 Priorities – Revised November 22, 2022

OVERVIEW

As of FY23, South Carolina First Steps receives \$3 million recurring annually from the General Assembly in General Funds to be distributed to local partnerships through competitive and targeted grants. The purpose of these funds is to prioritize evidence-based programs for children birth through age three, who live in rural communities and in communities where kindergarten readiness scores are consistently below the state rate.

RURAL. For READY priorities, rurality is defined by the South Carolina Office of Rural Health from the 2010 version of the United States Department of Agriculture Rural-Urban Continuum Codes. This document outlines the rural definition at the county (31 counties) and census tract level within 15 counties designated as urban.

KINDERGARTEN READINESS. For READY priorities, kindergarten readiness is defined as the proportion of students scoring “demonstrating readiness” on the South Carolina Kindergarten Readiness Assessment (implemented statewide in Fall 2017). This document outlines kindergarten readiness defined at the county-level below the state rate for five (23 counties), four (8 counties), or three (5 counties) years of administration. Below the county-level, it is defined as elementary schools within 7 counties, where the school scored below the state rate for all five years of administration. There are three counties (Fairfield, Georgetown, and McCormick) where no elementary schools that meet this definition of “consistently low KRA scores” at the school-level.
