Ms. Mjartan conducted a roll call.



Ms. Mjartan stated there were no members of the public who were present requested to speak.

Mr. Morley called the meeting to order at 2:03 p.m. Mr. Morley reported on the Executive Committee and introduced new Board members, Director Robert Kerr of Department of HHS and Nicole Wynkoop. He acknowledged Debbie Robertson's retirement and thanked her for her contributions to SC First Steps.

Dr. Matthew Lavery presented on the Kindergarten Readiness Assessment (KRA) results. Statewide 27% of students demonstrated readiness to engage with kindergarten readiness instruction.

Mr. Morley requested a motion to adopt the agenda. Dr. Williams provided the motion. Mr. Holt provided a second and the motion was unanimously approved.

Mr. Morley asked for a motion to approve the April 15, 2021 minutes. Dr. Canright provided the motion. Ms. McConnell provided a second and the motion was unanimously approved.

Mr. Morley asked for a motion to approve the following consent agenda. Ms. McConnell provided the motion. Dr. Canright provided a second and the motion was unanimously approved.

Consent Agenda: Motions Recommended by Committees (David Morley)

- a. Motion to approve revising the FY22 First Steps Program and Operational Guidelines for Core Functions by adding language clarifying the existing requirement regarding "operation in a location accessible to the public" by adding the following:
 a dedicated physical space in their county with appropriate signage that is accessible to the public and clients they serve. This will provide an official Local Partnership address that is open according to a set weekly schedule with publicized hours that are posted publicly. In addition, phone access will be available during regular business hours each week that includes voice mail and the capability to receive and return messages (phone, text, email, etc.) in a timely manner. (Programs and Grants Committee recommends)
- b. Motion to approve the Local Partnership budgets for state funds as proposed in their Funding Formula grant applications and summarized in the attached report. Upon final grant application review after the fiscal year ends, corrective action plans may be issued as part the FY22 grant award process in cases where grant qualifications for funding were not met. (Programs and Grants Committee recommends)
- c. Motion to approve adding Healthy Steps and Family Connects to the First Steps Board Approved List of Evidence Based Programs. (Program and Grants Committee recommends)

Mr. Fleming reported on the Finance and Administration Committee. He announced that the SC First Steps state office move to 636 Rosewood Drive has been delayed and will take place at the end of July. First Steps staff is working with Abbeville County First Steps and Greenwood County First Steps and their attorneys to resolve corrective action items that were identified in the 2019 Financial Audit. Abbeville County First Steps has submitted a Corrective Action Plan that will bring them into compliance if completed over the next year. Greenwood County First Steps has also submitted a Corrective Action Plan that will bring them into compliance if completed over the next year. However,



there are concerns that have been identified and they have been turned over to the Inspector General's office and the Legislative Delegation have been made aware. The accounting firm representing the partnerships will not release the audits for 2020 until the Inspector General's office completes their investigation.

Ms. McConnell thanked Ms. Robertson for her work with the Program and Grants committee in lieu of her retirement. Ms. McConnell reported on the Programs and Grants Committee. She reviewed the revision of the FY22 First Steps Operational Guidelines regarding Core Functions. Ms. McConnell discussed the addition of Healthy Steps and Family Connect to the Approved List of Evidence Based Programs. She also went over the grant and funding information breakdowns for the Local Partnerships.

Dr. Williams reported on the Strategic Planning and Evaluation Committee and provided updates on current projects and the Data and KITS system that are being developed.

Ms. Mjartan provided the Executive Director's report. Results from the Client Voice Program Evaluations were shared. Ms. Mjartan gave an update and timeline on the build out of the Knowledge, Information, and Teaming System (KITS). She reviewed additional philanthropic grants. Ms. Mjartan provided a legislative update on the budget process, introduced new team members, and presented the agency's vacancies.

Mr. Morley asked for a motion to adjourn the meeting. Dr. Canright provided the motion. Mr. Holt provided a second and the motion was unanimously approved.

The meeting was adjourned at 3:23 pm by Mr. Morley.

The Executive Committee of the Board of Trustees met on July 16, 2021 and August 9, 2021. Minutes of the meetings are attached. The following motions were approved unanimously. At the August 9th meeting, the committee acted on behalf of the full board in performing the Agency Head Director's Annual Performance Review. The following votes were taken:

Motion to rate Executive Director Mjartan as "exceeds" in all categories of the review.

The agency head review has been shared with all board members, including the cumulative scores for each question on the survey that Trustees completed. Thanks to each member who took the time to complete the Agency Head Review Survey. This information was used by the committee to perform the agency head review.

Board Additions and Transitions

We are pleased to welcome **DHHS Director Robert Kerr** and parent of a young child **Nicole Wynkoop**. These new members were both introduced with their bios at our last meeting, but as this is the first meetings they are attending, we wanted to recognize them again.

Board-to-Board Regional Meetings

As has been noted previously, a series of Board-to-Board Regional Meetings kicked off in December 2020 with each region having an opportunity to participate. All regional meetings have now taken place. These were fruitful, and we thank our state board members as well as local partnership board members for actively participating. We look forward to having these meetings again next year.



Executive Committee Meeting Minutes

July 16, 2021, 11:00 am, by Zoom

The Executive Committee met on July16, 2021 at 11:00 am via Zoom. Members present were David Morley, Dr. Shelley Canright, Jennifer McConnell, and Dr. Amy Williams. Members absent were Sen. Gerald Malloy and Walt Fleming. Executive Director Georgia Mjartan was present, and Karen Oliver, Program Manager for the Early Childhood Advisory Council, attended the beginning of the meeting.

Chairman Morley called the meeting to order at 11:00 am. The order of the agenda was rearranged so the Early Childhood Advisory Council business could be presented first. Mjartan presented an update on the status of the Birth through Five Plan, reminding members of the importance of the upcoming August Board meeting and subsequent B-5 Plan work session. Mjartan also provided information about the SC Summit on Early Childhood. Karen Oliver provided additional information about The Summit.

Mjartan presented an update on actions taken by the General Assembly during the 2021 session relevant to South Carolina First Steps and the ECAC, including significant budget increases and proviso changes impacting First Steps 4K. There was discussion about the implications of the provision allowing 5-year-olds to attend 4K if they were eligible the previous year but did not attend. The following budget information was presented:

Legislative Session Update - \$15,679,911 in new funding

- I. \$15,435,911 added to First Steps 4K to expanded statewide
 - \$10,215,935 in recurring EIA
 - \$5,219,976 in one-time, EIA
- II. \$142,448 for Data System
 - Recurring, General Funds
- III. \$102,000 for Early Childhood Advisory Council
 - Recurring, General Funds
- IV. 16 FTE's

Mjartan shared positive news about a partnership between the South Carolina Department of Education and South Carolina First Steps. SDE will provide significant funding to SC First Steps from ESSER III (federal emergency education relief funds) to address the academic impact of COVID-19. The funds, all targeted at young children five and under, will enable South Carolina First Steps to expand existing programs and add new interventions with proven efficacy in improving early childhood outcomes. A press conference will be held July 28th, and more details will follow. Until that time, information is embargoed. Members present remarked on the strength of the partnership with SDE and how valuable it is that the South Carolina Department of Education has chosen to invest some of the ESSER III funds in early childhood.



Mjartan gave updates on two significant, grant-funded projects: Connected Families, which is funded by The Duke Endowment and the Doris Duke Charitable Foundation, and AmeriCorps.

The three year project period for Connected Families began July 1, 2021, and progress is already being made. A project coordinator has been hired, local partnerships have begun recruiting parent educators, and partnership meetings with the key partners have all taken place (DMH, DSS, PAT National, and SCIMHA).

The first year of the AmeriCorps project was just completed, with 31 members engaged in service and 20 who completed terms. 13 members will be returning for a second term in August for the 2021 – 2022 AmeriCorps project year. 34 families completed HIPPY (an intensive home visiting program delivered by the AmeriCorps members), 12,227 families received information and education about First Steps programs and resources, 1,871 families were referred to programs that meet their young children's needs, 1,893 books were distributed throughout the year and an additional 373 books were distributed through the Martin Luther King, Jr. Day of Service Project. Mjartan reported that recruitment is currently underway for AmeriCorps for 2021 – 2022. New local partnerships sites mean more opportunities for AmeriCorps members to serve throughout the state, and more opportunity to use this valuable resource to reach children and families. Mjartan encouraged Executive Committee members to spread the word about the opportunity to serve as an AmeriCorps members.

Summarizing the impact of these significant grant investments, the historic increase from the legislature, and anticipated funding from ESSER III through SDE, Mjartan shared a draft revenue projection for FY2022 indicating significant budget growth. Mjartan talked through the implications, especially for 4K.

Mjartan provided a report on First Steps 4K, outlining the agency's data-driven approach to statewide expansion. With clear targets for student enrollment, center and classroom participation, and geographic reach, the agency is hyper-focused on using the funds available to grow First Steps 4K aggressively while maintaining the highest quality. Expansion will have implications for staffing – additional coaches are being hired – and will require the purchase or lease of additional vehicles. Mjartan provided updates on children accepted, centers and classrooms approved, and targets.

A discussion about local partnership operations included a focus on governance and the agency's approach to sharing information about diversity, equity and inclusion. Mjartan shared that Derek Cromwell, the new Chief Partnership Officer, has prioritized going out into the field to visit partnerships in person, with over a dozen visits already completed or in the works for the coming weeks. With the grant awards approved at the last board meeting and the funding made available to partnerships through the Connected Families project, South Carolina First Steps has awarded its single largest amount to partnerships in 15 years. First Steps has a media strategy related to this including check presentations involving local media and legislative delegations and a state-level press released that can be customized locally.

The meeting concluded with a brief update on the move to Rosewood July 26 – 30, information about new hires and current vacancies, and a reminder about the Agency Head Review Process.



Mjartan exited the meeting so members could meet privately to review the results of the survey completed by most members of the Board of Trustees regarding the Executive Director's performance for FY2021. The members reviewed the Agency Head Goals established in the planning document and established a date to reconvene to vote, on behalf of the full board, on the agency head's review, for submission to the Agency Head Salary Commission. The group will reconvene on Monday, August 9th, at 11:00 am.

With a motion to adjourn by Shelley Canright and a second by Jennifer McConnell, the meeting concluded at 1:00pm.



Executive Committee Meeting Minutes

August 9, 2021, 11:00 am, by Zoom

The Executive Committee of the Board of Trustees of South Carolina First Steps met by Zoom on August 9th for the purpose of discussing and finalizing an annual performance review for Executive Director Georgia Mjartan. The meeting was called to order by Chairman David Morley at 11:00 am. Members present were as follows: David Morley, Dr. Shelley Canright, Jennifer McConnell, Walt Fleming, Dr. Amy Williams. Members absent were as follows: Sen. Gerald Malloy, Georgia Mjartan was present at the beginning of the meeting to answer questions, then she left the meeting while the members discussed her performance. She returned to the meeting for a discussion of the review.

The members took action on behalf of the full board due to the time-sensitive nature of the agency head review needing to be submitted to the legislative committee (Agency Head Salary Review Committee) on August 13, 2021, prior to the next board meeting. The executive committee today took two votes, in both acting on behalf of the full board. The votes were as follows:

Motion to rate Executive Director Mjartan as "exceeds" in all categories of the review. Motion by Amy Williams, Second by Walt Fleming, unanimous approval

Motion to accept the review of Georgia Mjartan with edits discussed. Motion by Walt Fleming, Second by Amy Williams, unanimous approval

In response to a discussion about ways South Carolina First Steps can support the local partnerships, Mjartan shared with the members about the continued feedback the office has been receiving regarding competitive grants. There was some discussion about the FY2023 budget request, the intention to request significant funding to expand programs targeting birth through three, and the idea that the request would not only be restricted to program funding and competitive grants to local partnerships but would also include targeted funding and funding responsive to the needs relayed by local partnerships. The committee concurred with this approach.

The Finance and Administration Committee met via Zoom conference call on July 21, 2021 to receive updates from staff. Detailed meeting minutes are attached. The committee brings forward no action items, and the following updates.

First Steps State Office

Mr. Barnes presented an update to the Committee on the following. The new year's State Budget, the 4K Program, and other items. In addition, he shared the following information.

Financial Report

2020-21: The YTD financial report was reviewed by Mr. Barnes. The organization spent less than budgeted for the 2020-21 fiscal year. This is due to the impact of COVID on the 4K providers. The state provided more than \$15.6 million in new funds for the 2021-22 fiscal year. Most of these funds are to expand the 4K Program statewide. Our total budget, at this point, for FY 2021-22 will exceed \$63 million, which is a large increase over 2020-21.

Local Partnerships: Update on Corrective Action Plans

The state office staff continues to work with Abbeville County First Steps and Greenwood County First Steps along with their attorneys to finalize the Corrective Action Plans that were identified in the 2018-19 Financial Audit. The State Inspector General is continuing their investigation into the situation. No action is requested at this point.

Local Partnerships: Update on Corrective Action Plans

The State Office is working with their attorney to develop a plan that would allow for Local Partnership employees to participate in the State Retirement System. We have met with PEBA's attorney and are working closely with Florence County First Steps.



Minutes from Finance and Administration Committee Meeting July 21, 2021

Meeting was called to order by Walter Fleming at 10:31 am.

First Steps State Office

Financial Report/State Budget Update

The YTD financial report for 2020-21 was reviewed by Mr. Barnes. The expenses were down for last year due to COVID, mostly in the 4K Program. In addition, the Revenue and Federal Funds increased. This left us with a large surplus. These funds will roll forward into the new year. Mr. Barnes also shared a report showing the beginning financial budget for the 2021-22 fiscal year. We received over \$15.6 million in new state funds for the new year. This, along with the additional Federal funds, has raised our total budget to over \$63 million in the new year. This allows us to implement a statewide expansion of the 4K Program for the new year.

Local Partnerships

Update on Blackbaud and Raisers Edge

We have made considerable progress on improving the speed of the Blackbaud Financial Management system. In addition, we have started working on implementing Raisers Edge, which is the fundraising system that was secured when we set up the contract for Blackbaud. Cindy Kellett, our new fundraising staff person is taking the lead on this effort.

Update on Corrective Action Plans

Mr. Barnes gave an update on the Corrective Action Plans that were requested related to the Financial Audits completed for FY 2018-19 for Greenwood County First Steps and Abbeville County First Steps. Working through the attorneys we have been able to agree in concept on Corrective Action Plans for both local partnerships. There are still two potential issues associated with the situation, but no additional actions are being recommended at this point. The State Inspector General's Office is continuing their investigation into the situation. No timeline has been presented at this point for the completion of the investigation.

Local Partnership Retirement Efforts

The State Office retained an attorney to assist with supporting Local Partnership staff to be eligible to enroll in the state's retirement system. We have met with the attorney from the State Retirement System (PEBA) and are working to develop a plan to resolve their issues. We are working closely with Florence County First Steps on this effort. There was general discussion on this issue.



4K Program

Staff gave an update on the program's status. This included an update on the statewide expansion efforts.




FY 2021

The meeting was held on Monday, July 12, 2021 from 1-2PM via Zoom. Janie Neeley and I were present from the committee. Others present are noted in the minutes. The meeting was opened with the results of the May 2021 First Steps 4K Parent Survey. Chelsea reminded us of the two prevalent program evaluations that are currently underway for Parents as Teachers and Child Care Technical Assistance. The bulk of the meeting was spent discussion potential metrics for South Carolina's Birth through Five Strategic Plan. Highlights of the discussion include how to measure child wellness, social-emotional development, developmental screening, and early intervention at the population-level.

MINUTES

The meeting was called to order at 1:03PM. The meeting was opened with the results of the May 2021 First Steps 4K Parent Survey (attached). Chelsea reminded us of the two prevalent program evaluations that are currently underway:

- Parents as Teachers (due November 1, 2021): in progress with UofSC Institute for Families in Society
- Child care quality enhancement and training (due November 1, 2022): scope currently being drafted

Bill Potapchuk of the Community Building Institute, who is one of the consultants helping South Carolina write the Birth through Five plan joined the discussion about potential metrics for measuring the plan's progress. Chelsea opened the discussion with some criteria for data points that we may want to consider, including those that are available at the population-level, updated annually, and ability to be disaggregated into subgroups. Subgroups that were discussed were: race/ethnicity; disability status; poverty. Bill also reminded the group that the metrics we choose should be ones we can move the needle on in five years.

Each system goal was discussed with what important metrics come to mind. There was a lot of discussion about how to measure child wellness, social-emotional development, developmental screening, and early intervention at the population-level.

The meeting was adjourned at 2:02PM.
