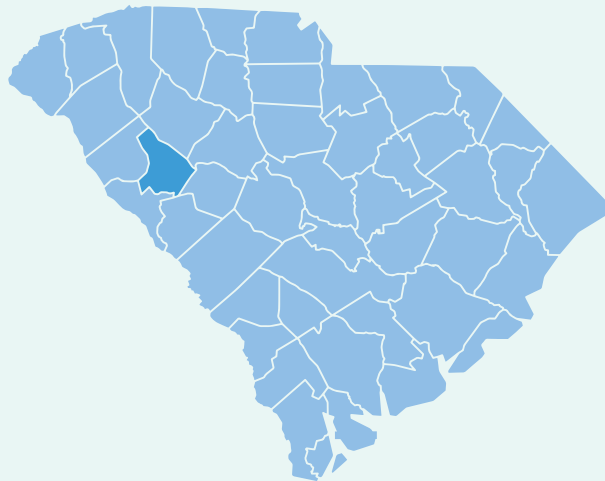

FINANCIAL HIGHLIGHTS

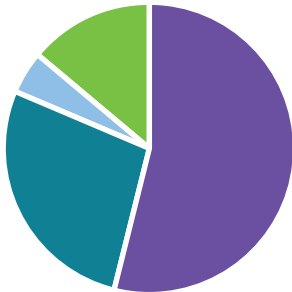

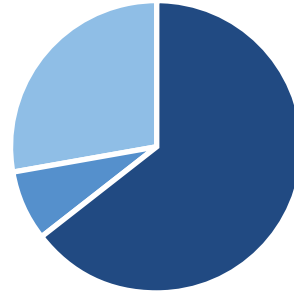
