Priority Needs: Summary

Through a series of community convenings, a needs assessment and asset mapping process, the following needs were prioritized for Charleston County. See our full needs assessment here: Charleston County First Steps.

- 1. Parents actively engage as their child's first teacher and advocate.
- 2. Access to high quality child care that include family child care homes, infant/toddler, preschool, and 4K classrooms.
- 3. Children's social-emotional development is supported through anti-bias practices.

Objective One: Increase the support and use of First Steps programs

STRATEGY 1.1

Parents as Teachers

SMART GOAL(S)

- 1. All full time Parent Educators will reflect a caseload of 18-20 families.
- 2. Increase average attendance at socializations/group connections by 10% each year.

 We will partner with Charleston County School District, SC Aquarium, Charleston County Public Library, Charleston County Parks & Recreation, Florence Crittenton, and the community at large.

SMART GOAL(S)

- 1. Maintain Raising a Reader classrooms.
- Find funding and implement new Motheread/Fatheread literacy program

Objective One: Increase the support and use of First Steps programs

STRATEGY 1.3

Child Care Quality Enhancement

SMART GOAL(S)

- 1. Five new child care facilities will participate in the program for two years.
- 2. Promote ABC Quality to increase number of child care providers participating from 40% to 43%.

Objective Two: Community Outreach and Education

STRATEGY 2.1

Strengthen Community Collaboration

SMART GOAL(S)

- 1. Participate in at least two community events each year that provides interactive learning activities for families with young children. Signage, branding, and recruitment materials will be available to advertise First Steps services.
- 2. Participate in community meetings and disseminate information about programs offered by Charleston County First Steps.

STRATEGY 2.2

Enhance grant writing efforts

SMART GOAL(S)

 Search and apply for at least one grant per year that focuses on Charleston County First Steps mission and services.

Objective Three: Children's socialemotional development is supported through anti-bias practices

STRATEGY 3.1

Countdown to Kindergarten

SMART GOAL(S)

 Request funding to implement Countdown to Kindergarten and Countdown to 4K program.

COMMUNITY COLLABORATOR(S)

 4K child care classrooms, Charleston County School District, SC First Steps Office

STRATEGY 3.2

Child Care Professional Development & Training

SMART GOAL(S)

- Charleston County First Steps will provide 20 certified training hours of professional development a year to child care providers with at least 6 training hours focused on supporting healthy social-emotional development in young children.
- 2. Create a professional development track for child care directors who have completed the two-year Quality Enhancement Program.

Objective Three: Children's socialemotional development is supported through anti-bias practices

STRATEGY 3.3

Parents as Teachers/Early Head Start PAT/Connected Families

SMART GOAL(S)

- At least one group socialization per year will focus on healthy social-emotional development in young children.
- Increase parent attendance at group socializations by 10% each year.

Overarching Measure(s) of Success

INCREASE THE AVAILABILITY OF HIGH-QUALITY EARLY CARE AND EDUCATION OPPORTUNITIES OFFERED BY CHARLESTON FIRST STEPS

By 2025, the percentage of children under age 6 who benefit from First Steps quality enhancement and training efforts will increase from 1% to 5%.

INCREASE THE NUMBER OF CHILDREN ENROLLED IN HIGH INTENSITY PROGRAMS FUNDED BY CHARLESTON FIRST STEPS

By 2025, the percentage of children in need who are directly served by First Steps high intensity programs will increase from 2% to 5%.

MORE CHILDREN ARRIVE AT KINDERGARTEN READY FOR SUCCESS

By 2025, the percentage of children who score at the highest level on the Kindergarten Readiness Assessment will increase by 2% each year to 55%.
