Objectives

Objective One: More students enter kindergarten demonstrating readiness.

STRATEGY 1.1

Proactively work to increase the number of kindergarteners demonstrating readiness.

SMART GOAL(S)

- By FY26, the percentage of Oconee County Children who score the highest level of the Kindergarten Readiness Assessment will increase 2% each year from 29% to 35%.
- 2. By FY25, Oconee County First Steps will partner with at least 2 schools to increases access to early literacy where the need is the greatest. By FY26 we will have increased the number of schools to 4.

STRATEGY 1.2

School Transition

SMART GOAL(S)

- 1. Implement C2K summer FY23 with the percentage of participating children increasing 2% each year.
- 2. Implement C2-4K in summer of FY24 with the percentage of children participating increasing 2% each year.
- Create a School Readiness council to connect local day Care Centers, Private schools and the Public schools and collaborate on school readiness.

STRATEGY 1.3

The Dolly Parton Imagination Library

SMART GOAL(S)

 Increase the registration in The Dolly Parton Imagination Library from 49% to 60%.

STRATEGY 1

Early screening, assessment and referral to services.

SMART GOAL(S)

 By the end of FY26, we will leverage our current Role as experts in Early Interventions to leading needed conversations for community priorities and increase referrals and connections to services by 25%.

 The School District of Oconee County, United Way, City and County Government, current partnering agencies and businesses.

STRATEGY 2

SMART GOAL(S)

 Each year we will hold at least two fairs/events that will include screenings, rotating locations through out Oconee County.

STRATEGY 1.1

Proactively work to narrow the gaps between White and Black/Hispanic students demonstrating readiness.

SMART GOAL(S)

1. By, FY26 we will narrow the gap from 20.5 % to 14.5%.

STRATEGY 1.2

Utilize web-based data tools that incorporate and tract level data To determine gaps in key services.

SMART GOAL(S)

 Gather and share data with community, OCFS Board, School district leaders, families and supporting agencies to follow progress monthly.

 Increase the number of Black/Hispanic families connected through Oconee NFP by 25% by FY25.

STRATEGY 2.1

Engage in Public information campaigns to reach targeted Populations and educate parents/caregivers.

SMART GOAL(S)

 By FY25 enhance our Social Media presence through our website and Facebook accounts including original posts and surveys.

Overarching Measure(s) of Success

1. More children arrive at Kindergarten ready for success.

By FY26, the percentage of Oconee County children who score at the highest level of Kindergarten Readiness Assessment will increase from 29% to 35%.

2. More children will be screened, assessed and referred to Early Intervention services.

By FY26, the percentage of children participating in screening, will increase from 2% each year, going from 10% to 16%.

3. The gap will narrow for White and Black/Hispanic Kindergarteners.

By FY26 this race/ethnicity gap will decrees from 20.5% to 14.5%.
