Serve as a resource for quality improvement and accountability using relationship-based principles and practices to drive improvement. 4K Coaches will collaborate with First Steps staff to develop and promote program accountability, instructional practices, and professional development structures which meet legislative requirements and advance best practices in early childhood education.

Must be self-motivated and capable of delivering high quality work. This position will work under the direct supervision of a 4K Manager, and the 4K State Director. Must display the ability to work independently while maintaining accountability.

- Conduct regular coaching visits for teachers that build relationships with providers to support the implementation of high-quality early learning curricula and best practices in First Steps 4K classrooms. Model effective teaching strategies and classroom management techniques while offering feedback and guidance to assess instructional effectiveness with goals of improving instruction and lesson planning. Support teachers in integrating literacy, numeracy, social-emotional, and play-based learning.
- Oversee implantation of student assessment tools for performance and progress of skills. Guide teachers in using data to inform instruction and improve student outcomes. Conduct classroom observations to assess instructional and program effectives. Assist in collecting and analyzing data for program evaluation and improvement to share with teachers and leaders.
