Mr. Morley called the meeting to order at 2:08 p.m. Mr. Morley requested a motion to adopt the agenda. Dr. Canright provided the motion. Mr. Holt provided a second and the motion was unanimously approved.

Mr. Morley asked for a motion to approve the February 16, 2023 minutes. Mr. Holt provided the motion. Dr. Canright provided a second and the motion was unanimously approved.

Mr. Aaron and Mr. Wilson discussed how the program is implemented in their community. Mr. Myers shared his experience as a participant of the program.

Sen. Hembree provided a legislative report where he commended Ms. Mjartan and staff on educating the General Assembly about First Steps. He shared information on the budget and the legislation proposals regarding the reauthorization of First Steps and the restructuring of First Steps local partnerships.

Ms. Mjartan provided the Executive Director's report where she acknowledged the retirement of Virginia Newman, Calhoun County First Steps Executive Director and Barbara Manoski, Spartanburg County First Steps Executive Director. She shared information about the success of the Readln SC event that was held and the fundraiser being held that evening. She provided information and statistics on First Steps 4K. Ms. Mjartan provided an update on the Your Voice Matters First Steps 4K Spring Family Survey and an update on the agency's grantmaking status and process. She introduced new staff and highlighted the agency's Infants in the Workplace policy.

Strategic Planning and Evaluation Committee

CHAIRWOMAN'S REPORT

The committee meeting took place on Monday, May 22, 2023 via Zoom and was called to order at 9:33AM. The committee members present were myself and Janie Neeley. There were several staff and guests present.

The meeting focused on Countdown to Kindergarten (CTK), an evidence-informed program developed by First Steps in the mid-2000s. The main keys to success of CTK are: (1) building relationships with child's soon-to-be kindergarten teacher or teaching assistant; (2) increasing parent knowledge and competence in kindergarten expectations and how to support learning at home; (3) using and distributing high quality materials with families.

Funded by the Preschool Development Grant (PDG), the agency has commissioned the University of South Carolina's Research, Evaluation, and Measurement Center to evaluate CTK at several levels. This aligns with the agency's strategic plan (Strategy 1.4.8: "Evaluate the impact of the Countdown to Kindergarten program using both quantitative and qualitative methods") and with the program's plans of building enough evidence for the board's consideration for moving it from an "evidence-informed" to an "evidence-based" designation. The definitions of "evidence-informed" and "evidence-based" can be found in S.C. Code 59-152-25.

The presentation described the program and the pilot and scaled evaluations that have taken place to date. Details about the studies and their associated manuscripts in development are included in the attached fact sheet. The high-level takeaway findings from the scaled evaluation are:

- Students who participated in CTK had significantly higher skills in language and literacy, math, and social foundations and had significantly stronger home-school relationships, than those who were eligible, but did not participate.
- Families who participated in CTK had, on average, significantly more connectedness with schools, stronger parent-teacher relationships, and more parent knowledge about kindergarten expectations, than families who did not participate in CTK.

Dr. D'Amico also shared the future directions of this work, which is funded by the PDG Planning Grant this calendar year. There was deep discussion between the committee and the presenters regarding the future work and its implications. The meeting adjourned at 10:28AM.

MINUTES

The meeting was called to order at 9:33AM and opened with an announcement that an evaluation coordinator, Dr. Roddrick Dugger, will be joining the First Steps team on June 2, 2023. This addition will bring the agency's dedicated data and evaluation team to a total of five full-time staff, including its Director, a testament to the agency's commitment to data-driven decision making.

Chelsea relayed to the committee that the meetings planned for the remainder of the calendar year will focus more on showcasing the agency's multifaceted approach to evaluation and less on updates. This meeting focused on Countdown to Kindergarten (CTK), an evidence-informed program developed by First Steps in the mid-2000s. Using funding from the Preschool Development Grant (PDG), First Steps commissioned the University of South Carolina's Research, Evaluation, and Measurement Center to evaluate CTK at several levels. This aligns with the agency's strategic plan (Strategy 1.4.8: "Evaluate the impact of the Countdown to Kindergarten program using both quantitative and qualitative methods") and with the program's plans of building enough evidence for the board's consideration for moving it from an "evidence-informed" to an "evidence-based" designation.

Pursuant to S.C. Code 59-152-25, the definition of evidence based is: "a program based on a clear and consistent program model that is designated as such by the South Carolina First Steps to School Readiness Board of Trustees because the program:

(1)

- (a) is grounded in published, peer-reviewed research that is linked to determined outcomes;
- (b) employs well-trained and competent staff to whom the program provides continual professional development that is relevant to the specific model being delivered:
- (c) demonstrates strong linkages to other community-based services; and
- (d) is operated to ensure program fidelity; or

(2) is commonly recognized by experts in the field as such a program."

Traditionally, programs are recommended as evidence based after thorough review by a team of qualified staff, all holding PhDs with a combined 50+ years of research experience, to the Program and Grants Committee of the First Steps Board for their consideration.

Drs. Janice Kilburn and Leigh D'Amico presented the CTK evaluation approach and findings to the committee. Dr. Kilburn opened the presentation with an overview of the program, which pairs incoming kindergartners with their soon-to-be kindergarten teacher for five personal visits and one school visit in the summer before kindergarten. The main keys to success of CTK are:

(1) building relationships with child's soon-to-be kindergarten teacher or teaching assistant; (2) increasing parent knowledge and competence in kindergarten expectations and how to support learning at home; (3) using and distributing high quality materials with families.

Then, Dr. D'Amico described the pilot and scaled evaluations that have taken place to date and the associated manuscripts that are in development. The attached fact sheet includes the details. The high-level takeaway findings from the scaled evaluation are:

- Students who participated in CTK had significantly higher skills in language and literacy, math, and social foundations and had significantly stronger home-school relationships, than those who were eligible, but did not participate.
- Families who participated in CTK had, on average, significantly more connectedness with schools, stronger parent-teacher relationships, and more parent knowledge about kindergarten expectations, than families who did not participate in CTK.



CTK closes the gap in children's academic skills and home-school relations

Children who participate in CTK had statistically significantly higher language and literacy skills; math skills; social foundation skills; and stronger home-school relations, on average, compared to students who were eligible but did not participate in CTK.

Of the 617 students, the eligibility status for 201 students was unknown. Of the remaining 416, 42% (n=176) were eligible and participated in CTK, 28% (n=117) were eligible but did not participate in CTK, and 30% (n=123) were not eligible to participate in CTK.



**Language and literacy, math, and social foundation scores are on a scale from 1 (Not Met) to 4 (Fully Met). Home-school relations scores are on a scale from 1 (Not Engaged) to 3 (Engaged).

The Local Partnerships Program and Grants Committee met on June 5th, 2023, to receive updates and address action items. Detailed minutes of that meeting are attached.

Action Items

1. Corrective Action- Lancaster County First Steps

Derek explained that we generally are not considering Corrective Action items at this meeting, however the items were urgent enough that action is not only being taken in this committee, but also had been taken up in the Finance and Administration committee at its May meeting. Lancaster County First Steps first steps is being recommended for corrective action for several reasons related to the Clyburn Child Development Center. Items of deficiency include 1) Failing to receive competitive bids for contract valued at over \$105,000, 2) making capital improvements to a facility without a signed lease or contract, 3) failing to request and receive State Board of Trustee approval for capital improvement spending. The following motion was made by John Hayes, seconded Wes Wooten, and unanimously approved for the consent agenda:

Motion: The Local Partnership Program and Grants Committee approves the corrective action determination as presented for Lancaster County First Steps. As a result of corrective action, the Lancaster County First Steps is not eligible to apply for competitive or targeted grants until they have satisfactorily resolved the deficiencies noted on their corrective action plan as determined by SC First Steps.

2. Program and Operational Guideline Updates

Derek explained the purpose of bringing the Program Guidelines to vote. Every year we bring the program and operational guidelines to the committee for updating. This year, due to the number of items updated, and to be more streamlined in the number of action items we brought before the committee, we included a summary of changes to the committee and put all updates in one action item. Items to be updated after discussion as required by motion are noted in the attached minutes. A separate motion will be introduced to the full board defining the age of service for children participating in the Early Care and Education onsite Tutoring program to define age eligibility. The following motion was made by Jesica Mackey, seconded by John Hayes, and unanimously approved for the consent agenda.

Motion: The Local Partnership Program and Grants committee approves the Program and Operational Guidelines with updates by SCFS Staff for implementation for the Grant Year 2024 beginning July 1, 2023.

3. Grant Year 24 Formula Funding Request Approval

Kerry and Derek gave an overview of the Local Partnerships Formula Funding Grant request for grant year 2024. See attached funding request document. During the discussion, it was questioned by



committee why there were expenditures in the "scholarship" line item for a program where local partnerships do not spend dollars on scholarships. The scholarships are provided free to SCFS by DSS. It was explained by staff that the amount in the line item was actually program management cost that was entered through budget allocation, and not direct cost of scholarships. Committee recommended that the program management cost be limited to 25% of value of scholarships each local partnership will distribute in their counties. That requirement is reflected in the motion. The following motion was made by John Hayes, seconded by Wes Wooten, and unanimously approved for the consent agenda.

Motion: The Local Partnership Program and Grants Committee recommends the approval of the Formula Funding grant requests, with the exception of the Scholarship Program in which budgeted administrative cost not exceed 25% of the value of the scholarships received from DSS as recommended by SCFS Staff to the forty-six (46) First Steps Local Partnerships for Grant Year 2024 beginning July 1st, 2023.

4. READY Grant Award Recommendation (Competitive)

Chelsea explained the review process in which the 13 grants were recommended by SCFS staff. Twelve (12) local partnerships are being recommended for thirteen (13) grant awards, with one local partnership being recommended for two (2) awards. The following motion was made by Jesica Mackey, seconded by Wes Wooten, and unanimously approved for the consent agenda.

Motion: The Local Partnerships Program and Grants Committee approves thirteen (13) grant awards for the Resources for Early Acceleration and Development in Youth (READY) Grants in order to serve more children and families in their communities. - Failed to get competitive bids for contract worth over \$105,000 awarded to a single vender as required by state law.
- Expended funds to make capital improvements to a facility and operated facility without appropriate contracts for a lease.
- Failed to get approval from SCFS State Board of Trustees for capital improvements as required by state law
- Finance and Administration Committee approved corrective action at its May 2023 meeting.

Motion

The Local Partnership Program and Grants Committee approves the corrective action determination as presented for Lancaster County First Steps. As a result of corrective action, the Lancaster County First Steps is not eligible to apply for competitive or targeted grants until they have satisfactorily resolved the deficiencies noted on their corrective action plan as determined by SC First Steps.

Derek opened by explaining the purpose of the annual review of Program and Operational Guidelines. Action Item 3: Formula Funding (see attached funding request and breakdown)

Kerry and Derek gave an overview of the Local Partnerships Formula Funding Grant request for grant year 2024. See attached funding request document. During the discussion, it was questioned by committee why there were expenditures in the "scholarship" line item for a program where local partnerships do not spend dollars on scholarships. The scholarships are provided free to SCFS by DSS. It was explained by staff that the amount in the line item was actually program management cost that was entered through budget allocation, and not direct cost of scholarships. Committee recommended that the program management cost be limited to 25% of value of scholarships each local partnership will distribute in their counties. That requirement is reflected in the motion.

The Local Partnership Program and Grants Committee recommends the approval of the Formula Funding grant requests, with the exception of the Scholarship Program in which budgeted administrative cost not exceed 25% of the value of the scholarships received from DSS as recommended by SCFS Staff to the forty-six (46) First Steps Local Partnerships for Grant Year 2024 beginning July 1st, 2023.

Action Item 5: READY Grant Award Recommendation (Targeted- See attached funding request and breakdown)

Derek, Jon and LaMyra explained the two (2) Targeted grant opportunities covered by this award, Family Café and Supporting Care Providers Through Visits (SCPV, the process in which the grants were reviewed, the amounts for each local partnership, and the total amount of \$50,500 committed in READY funding. The following motion was made by Jesica Mackey, seconded by Wes Wooten, and unanimously approved for the consent agenda.

- a. Family Cafés are structured discussion groups that use the principles of adult learning and family support. They are highly sustainable with training reinforcement, institutional support, and a commitment to an approach that engages and affirms parents as leaders. Participants leave Family Cafés feeling inspired, energized, and excited to put into practice what they've learned."
 - Six (6) Local Partnerships applied to be funded for the targeted grant opportunity for Family Café' which supports Core Function work within our local partnerships.
 - The Local Partnerships recommended for funding are, Barnwell, Darlington Fairfield, Greenwood, Lee, and Williamsburg.
 - \$71,900 has been committed in this funding recommendation.
- b. Supporting Care Providers Through Visits (SCPV): Supporting Care Providers through Visits (SCPV) strives to give care providers research-informed information and evidence informed practices that are supportive and educational. In addition to helping care providers better serve, the SCPV curriculum offers materials (Parent Pages) to help parents be better teachers in the home.
 - Four (4) Local Partnerships applied to be funded for the targeted grant opportunity for SCPV.
 - The Local Partnerships recommended for funding are, Beaufort, Charleston, Colleton, and Williamsburg.
 - \$50,500 has been committed in this funding recommendation.

All Other Program Guidelines Proposed changes for FY '24

School Transition

- Throughout the Program Guidelines, replaced "home visitation" wording with "sessions", "school transition", or similar, to indicate that Countdown to Kindergarten programming is no longer expected to be home visitation.
- Service Delivery: Added service delivery expectation of length of sessions (45 to 60 minute). This was stated as expectation in other documents, such as Countdown to Kindergarten MOA, but it needs to be included in Program Guidelines.
- Service Delivery: Changed expectation of sessions from no more than two sessions/week to no more than three sessions/week. This is to address a shortened summer break for several school districts.
- Ongoing Program Quality Improvement and Professional Development: Changed guidance to reflect new Countdown to Kindergarten teacher training platform, which no longer offers discussion forum -Countdown teachers, Bilingual Specials, and Disabilities Specialists are to reach out to available supports when needed. These include their First Steps Local Partnership, South Carolina First Steps, their local school, and/or Countdown Mentors.
- Data Submission and Fiscal Reporting: Took out wording that alluded to older parent survey (pre/post)
 which some Local Partnerships used. It is only offered now upon request. Other survey is shorter, postonly satisfaction survey.

Enhanced Early Education Onsite Tutoring

- Added an additional "Enhance Early Education risk factor" "Child has been prioritized as most in need of additional support as identified by the classroom teacher and student assessment data."
- Took out "students aged 3 through 5" and changed to "students in 3K through 5K classrooms (must meet First Steps age eligibility requirements)"
- Added KRA to assessments used to identify children needing additional supports.
- Added principals and childcare directors to satisfaction survey clients.

Child Care Quality Enhancement (QE) and Quality Counts (QC)

• I had to make changes in the qualifications for TA providers because currently, there is not a Technical Assistance Provider (TAP) certification with our state's certifying body, SC Endeavors. I added minimum qualifications for TAPs (this is different for QE and QC).

 Added to QE that a partnership may request a waiver from us (SC First Steps Local Partnership team) if a childcare TA does not meet the qualifications. That person would then receive additional support from the Early Care and Ed. team.

Core Functions, Family Café

• The removal of AmeriCorps language and replacing with "local partnership staff"

Program and Operational Guidelines

- Wording change to reflect that local partnership on-site monitoring can be done at any time and not just every 5 years.
- Additional wording to explain that the Formula Funding Grant is now on a 3-year cycle with annual progress reports.
- Additional wording to include the policy and steps for possible reduction in funding as the result of noncompliance with corrective action.

SUMMARY

In FY2022-23, South Carolina First Steps intends to award up to \$1,435,000 per year in Resources for Early Acceleration and Development in Youth (READY) competitive grants to local First Steps partnerships, renewable for at least one additional year, to serve more children and families in their community. READY priorities include evidence-based programs for children birth through age 3 who live in rural communities and in communities where kindergarten readiness scores are consistently below the state average. No more than 10% may be distributed to any one county and no more than 3% retained by the state office for administering, monitoring, and evaluating the program.

Priorities for this opportunity were to partnerships:

- applying to sustain the reach of effective programs funded by Preschool Development Grant and/or other funding sources whose grant periods have ended or are ending soon
- expanding existing, effective programs; and/or
- · establishing new programs or services.


Applications were due on May 3, 2023, and twenty applications from seventeen local partnerships were received. Each application was blind reviewed by a unique team of three reviewers (see process on next page). Reviewers and other staff came together to blindly discuss each application and make recommendations for funding. Thirteen applications are being recommended for funding. 



Lancaster County First Steps has had significant turnover in the last year and a half. This has included their Executive Director, Board Chairperson, and a number of critical staff positions. During this time, they have been working on completing the Clyburn Child Care Center in Kershaw. During that work they violated two sections of SC Law related to getting competition for bids and getting approval from our Board of Trustees to pay for capital improvements. In addition, they provided these capital improvements on a building where they did not hold a current lease. Staff is recommending a Corrective Action Plan for Lancaster County First Steps. The Committee has reviewed the request and has approved an amended Corrective Action Plan which is attached. Therefore, we are submitting the following Motion as part of the Consent Agenda:

Motion: To approve the Corrective Action Plan for Lancaster County First Steps as Amended.

First Steps State Office

Financial Report

2022-23: The YTD financial report was reviewed by Mr. Barnes. The organization continues to be in good financial condition. Expenditures to date are in line with projections.

Local Partnership Update

State Office staff are working with SLED on two ongoing investigations related to the Local Partnerships. Staff is working with First Citizens Bank and Manley Garvin to implement additional fraud protections.

Local First Steps partnerships not meeting one or more Minimum Qualifications may be subject to implement a Corrective Action Plan for the current fiscal year which specifies the qualification(s) not met and a summary of action steps to be taken for achieving compliance. The purpose of this process is to provide an opportunity for Local Partnership staff and board members to acknowledge the receipt of recommendations, and for Program Officers to approve reports of compliance. A list of Minimum Qualifications was included in the partnership's FY 2019-2020 Formula Funding Grant Application and is attached to this document for reference.

Corrective Action Plans may be issued, modified, or added to at any point during the grant year, as needed. Both initial and subsequent versions of Corrective Action Plans must be **signed** by the partnership Executive Director and Board Chair, as well as shared with the full partnership board at its next scheduled meeting and reflected in partnership board minutes.

Minutes from Finance and Administration Committee Meeting May 17, 2023

Finance and Audits

With all public notices being provided, the Zoom meeting was called to order by Tim Holt at 10:00 am. After introductions, a quorum was not available, so the Committee moved to the third item on the agenda, information from staff.

First Steps State Office

Financial Report

The YTD financial report for 2022-23 was reviewed by Mr. Barnes. SC First Steps continues to be in good financial shape. Our year-to-date expenditures are within our budgets and projections. At this point in the year, we have expended 73% against a projected 83%.

Mr. Barnes also mentioned the donations report and noted we have received over \$170,000 in donations this year. This is the largest amount we have ever reported receiving.

A quorum being established, the Committee moved to item number 2 on the agenda.

Required Action Item: Review and Approval, Corrective Action Plan for Lancaster County First Steps

Mr. Barnes shared the situation in Lancaster County. He mentioned the turnover in the Executive Director, and additional administrative staff and Board members over the last year and a half. He mentioned a number of concerns have been identified with their compliance with state law, the Grant Agreement and agency policies related to the procurement of permanent improvements and renovation of the Clyburn Child Care Center in Kershaw. There were two sections of state law violated, they include the lack of competition in selecting the contractor who provided over \$105,000 worth of renovations as well as failing to get approval from the SC First Steps Board of Trustees to provide capital improvements. In addition, they made these capital improvements to a facility they did not have under lease. With these concerns and violations of state law, First Steps staff is recommending a Corrective Action Plan (CAP) for the Local Partnership. It would have a time frame of 9 months to complete the actions necessary and would include additional oversight and an audit by First Steps Staff, as well as training for their staff. This time frame would give them the best opportunity to correct the issues before the next round of grants are awarded by SC First Steps. If they are on a CAP, they are not eligible to receive any additional grants. There was general discussion and questions regarding the

CAP and its implementation. Mr. Morley requested that we ensure that communications for this CAP are shared with the full Board and that meeting minutes documenting that are provided. Mr. Barnes would amend the CAP to make sure this was clear. Mr. Holt moved, with a second from Mr. Morley, that the Corrective Action Plan be approved. The motion passed unanimously. This will be included in the Consent Agenda for the upcoming Board of Trustees Meeting in June.

Motion: To Approve the Corrective Action Plan for Lancaster County First Steps as Amended.

Mr. Barnes continued with the updates from staff.

State Budget Update

SC First Steps requested several increases in the State Budget for FY 2023-24. There were three budget items approved by the House. The Senate approved all three in their budget, but two of the amounts were greater. They recommended fully funding the 4K request of \$5.2 million and \$851,000 for the ECAC. One item was the same, \$455,392 in recurring funds for previous cost increases. Both the Senate and the House approved our requested Proviso changes. This included the proviso that would allow First Steps to study coming out from under the Department of Education. At this point we are waiting for the Conference Committee to adjourn and make decisions on which version they are recommending to the General Assembly. (Note: The Conference Committee met on June 8 and will be recommending \$851,000 for the ECAC and \$4.2 million for 4K.)

Legislative Update

The Senate amended again and approved House bill H.4023, which is the First Steps bill that would provide permanent reauthorization to SC First Steps along with some other statutory changes. The Senate removed the requirement that the next First Steps Executive Director be appointed by the Governor, took out the language related to new hiring requirements for the Local Partnerships, and amended the requirement for the State Office of Procurement to approve the new Local Partnership procurement policies. Instead of approving, they will be collaborating with First Steps to develop the policies. The next step will be a conference committee to make bring the two bills into agreement and will send the revised version back to each body for a vote. Mr. Barnes mentioned that a lot of work had been done by Georgia, Kaitlyn and Mark to support this work.

Local Partnerships

Local Partnership Update

Mr. Barnes provided an update on the Local Partnerships. Abbeville County First Steps has completed their Corrective Action Plan and that LaMyra Sanders, their First Steps Program Officer is working with them closely. As a reminder, there are a couple of investigations that are ongoing by SLED. We are following these up and will are taking appropriate actions. Mr. Barnes is working with the bank for the Local Partnerships and Manley Garvin to put additional fraud protection in place. We are implementing a new system for verification of payments between the bank and Manley Garvin which should minimize any possible losses. The bank has been very helpful in reducing any additional costs to the Local Partnerships or to SC First Steps. There was general discussion about the Local Partnerships and the

Executive Director's in the Local Partnerships responsibilities. Mr. Barnes will keep the Committee up to date on any changes or new information.

4K Program Update

Staff is currently evaluating the rates to be paid for tuition for the upcoming fiscal year and will be recommending an increase, most likely, but the amount has not been finalized.





FY 2023-24 Budget - Updates

The state budget has been sent to conference committee, where the differences between the House and the Senate versions will need to be resolved. In the event they cannot reach an agreement, both bodies passed a continuing resolution which would extend current spending into the 2023-24 fiscal year.

The House of Representatives passed their version of the budget on March 15, 2023. The following items related to First Steps and the ECAC were included:






