
- 1. Officially launched February 17, 2022. A login system for programs to collect information for eligible families/leads was launched March 30, 2022.



Call to Order and Welcome

Georgia Mjartan convened the meeting at 1:05 PM. Each participant introduced him or herself and identified their representative agency.

Birth through Five Plan: Next Steps

Karen Oliver discussed updates to the Birth Through Five Plan Status Report. A simple draft was shared with ICC participants. The draft follows this recap. Discussion centered around selection of "wins," the BIG headlines that we might share with key stakeholders about our work.

- Dr. Traxler will obtain updated WIC information.
- Ms. Gillum will share language about significant wins in the area of child care.

Other wins the ICC will likely list include

- Extension of Medicaid services to 12 months for post partum mothers
- Launch of First Five (including data relating to its reach and the percent eligible for at least one program

There was discussion about increased investments in parenting and home visiting programs.

In order to present a draft for ECAC's consideration in February, the ICC will need to finalize selection of "wins" and determine milestones that will track progress toward Birth through Five Plan measures of success. The ICC will meet in person in January, on a Friday or Monday, to engage in this work.

Issue Briefs

Kaitlyn Richards brainstormed with ICC about the development of issue briefs. The briefs would provide information in response to trending early childhood issues of state wide importance. Potential topics discussed included early childhood and infant mental health and the state pre-K landscape. There was also discussion about what should be included in the briefs, including the following suggestions: any collaborative, inter-agency work currently being done, agency contacts, and a "call to action" that directly connects to the objectives found within the Birth Through Five Plan.

A draft issue brief will be presented for review at the ICC meeting in January.

ICC Collaboration Opportunities and Updates

DSS launched portal for (child care) vouchers end of October.

DMH is offering professional development, capacity building for clinicians. 25 open slots DHEC completed data walk for state health needs assessment; the state health plan is in development

Children's Trust waiting for MIECHV reauthorization.

State Library completed review process by Legislative Oversight Committee

Why we 're presenting the report

The Birth through Five Plan Status Report is important for two reasons. First, individual agencies complete a variety of reports for a range of audiences (legislative reports, grant reports, etc.), but this might be the first time a group has jointly created a compendium of achievements that document progress toward achieving outcomes for young children and their families.

Second, and perhaps most significant, the status report represents the shared agreement, accountability, and responsibility of ECAC and its partners to implement the Birth through Five Plan

WINS- These are the BIG headlines that we might share with key stakeholders about our work

Each win will include- WIN STATEMENT (see bullets on next page) and a couple of sentences about WHY this matters, how it will help young children and families and/or how it will improve efficiency or effectiveness as a system.

Select 5-7? No more than 10 Criteria for Selection

Achieved in the last 12 -15 months
Statewide impact
Affects a significant percentage of population
Significant process improvement that results in efficiencies and effectiveness (preferably for end users (i.e. parents)

Wins suggested by workgroups

- Medicaid extends postpartum care 12 months in April
- October declared Safe Sleep Month by Governor McMaster
- (WIC) Breastfeeding initiation increases to 23.1% as of July, 2022, exceeding 22% goal (SC WIC System participants in system)
- First Five SC Launched # using screener/% eligible, first phase common application
- More families have access to affordable child care and quality early care and education
 - through expansion of vouchers (for example Covid 300; essential vouchers, 4K+,then braiding of vouchers with other programs like Head Start and Early Head Start)
 - Statewide expansion of CERDEP
 - What number of families now have access?
- More childcare is available to families; licensed childcare providers increased by 4% from 2021 to 2022
 - 61% of those providers participate in a quality rating program, an increase in 10 percentage points from the year before (This bullet pending approval from DSS)
- Drive to Five Dashboard launched

Below are wins suggested during workgroup meetings but do not meet selection criteria Increases in Evidence-based parenting resources through PDG, ESSER, philanthropy

Help Me Grow more than doubles presence in counties, from 12-27 -Does not meet criteria

Partners for Early Attuned Relationships (PEAR) network in 26 counties, impacting 1498 infants and toddlers

Palmetto PreK Transitions Workgroup creates statewide plan and disseminates 12,000 packets to parents of children entering Kindergarten

Children's Trust Parenting Coordinator hired- new position to deepen and expand parent leadership across state

Head Starts sharing data with RFA

Milestones to Monitor

Below are milestones proposed by workgroups. They are significant, but mostly related to process. ICC may want to choose some from the list, and also add milestones that are differently measurable and more closely related to measures listed in B5 Plan. Like Wins, milestones should be presented simply, with some additional sentences that explain why these milestones matter.

- 1. WIC in integrated into early childhood data system (ECIDS RFA)
- 2. Central registry for child development screenings is organized (led by Child Wellbeing Coalition)
- 3. Post-partum Bundle in birthing hospitals
- 4. MIECHV reauthorization
- 5. Increase participation in four year old kindergarten
- 6. Family Care standards will be updated through Fall 2023
 - Increasing from three to five levels of quality, providing increased incentive to participate in subsidy and QRIS programs
- 7. Integration of Division of Early Care and Education Workforce Registry (SC Endeavors) includes program data of programs in child care licensing and QRIS and provides parental choice (SC-Child Care Resource and Referral) that results improved information for parents about "real time" availability and goodness of fit at child care sites and efficiency for workforce, reducing administrative burden for child care providers
- 8. Policy work on suspension and expulsion

Next Steps for Milestones Set criteria for selection To the degree possible and appropriate, make milestones SMART

Transitions

The workgroup continues to meet to implement tactics that support transition activities:

- a. Subgroups continue to meet to refine transitions toolkits for draft completion December 2022.
- b. Focus group information will be used to support the work of Countdown to Kindergarten, transitions in general, and the development of the toolkits.
 - i. First focus group piloted at Palmetto Pre-K Jamboree.
 - ii. A focus group was held at the SCAEYC conference on October 14.
 - iii. Four additional focus groups are scheduled for December.



Family Voice Council (FVC)

- 1. "A Year of Family Voice" report, published October 20, 2022, was included in the Parents as Teachers National Center Newsletter on November 7, 2022.
- 2. 20 parents now represent the Family Voice Council; three applications are held for possible openings in winter 2023.
 - a. Recruitment continues for seats opening in Winter/Spring 2023.
- 3. FVC meetings
 - a. October meeting: Michelle Myer, Director of the Division of Children's Health and Perinatal Services, SC DHEC presented
 - b. November meeting:
 - i. Follow-up about SC Early Learning Extension
 - ii. First Five SC Common Application to secure feedback prior to deployment.
 - c. FVC will be attend the Summit on Early Childhood and host a Family Voice studio session.

Grants

- 1. Preschool Development Grant (PDG)
 - ACF released a Notice of Funding Opportunity (NOFO) for a new planning grant. This planning grant could provide a path for another round of multi-year renewal funding.
 - a. SC submitted its application November 4. DSS agreed to serve as lead; DSS is the lead for the current PDG grant.
 - b. SC is one of 24 eligible applicants for this grant. The Administration for Children and Families (ACF), the grant administrator, expects to make 10 awards ranging from \$400,000 to \$4,000,000.
- 2. Alliance for Early Success
 - The ECAC continues its relationship with Alliance for Early Success. Georgia Mjartan, Kaitlyn Richards and Beth Moore attended an in-person conference in November.
