Ms. Jones conducted a roll call.

A quorum was not met. Mr. Morley addressed the attendance and participation of meetings going forward. The annual meeting is required in the SC First Steps Board bylaws. Mr. Morley reflected on his participation in the Local Partnership Executive Directors meeting that was held that morning.

Ms. Mjartan provided information on First Steps 4K + Siblings. She thanked Michelle Bowers of DSS, and Martha Strickland, 4K State Director for their partnership on ensuring the successful implementation of First Steps 4K + Siblings. Ms. Mjartan introduced Ms. Sheila Jones, grandparent recipient of the 4K + Siblings vouchers. Ms. Jones shared her experience with First Steps and how her family has benefited from the 4K + Siblings program.

Dr. Chelsea Richard reported on the Strategic Planning and Evaluation Committee. She provided an update on the new First Steps data system and the revisions to data reported in the annual report.

Ms. McConnell acknowledged the success on Summit on Early Childhood Summit that was held the day before. Mr. Cromwell reported on work of the Local Partnership Program and Grants Committee.

Mr. Holt reported on the Finance and Administration Committee. He shared that the agency is in a strong financial position.

Mr. Morley invited Dr. Fry to provide an introduction. He acknowledged trustees who have left their seat on the board. The trustees were Walter Fleming effective March 3, 2022, Rep. Rita Allison effective February 25, 2022, and Rep. Jerry Govan effective November 8, 2022. He also acknowledged Dr. David Mathis who will leave the board in January 2023.

Ms. Mjartan thanked all of the Executive Directors of Local Partnerships that were present. She acknowledged Executive Directors that retired or resigned and welcomed new Local Partnership Executive Directors. Ms. Mjartan shared an update on grants awarded to local partnerships and how these grants have impacted their communities. Ms. Mjartan shared that Sen. Hembree and Sen. Turner cosponsored a prefiled bill that would end SC First Steps sunset and make it a permanent agency. She also shared that the Pritzker Foundation awarded SC First Steps a \$200,000 grant which would allow SC First Steps to share First5 with other states and municipalities. She provided an overview of the 2021-2022 Annual Report. An update staffing, and vacancies was provided.

Dr. Michelle Fry resigned her position as the State Director of the SC Department of Disabilities and Special Needs on January 6, 2023. **Constance Holloway** who now serves as the Interim State Director of the SC Department of Disabilities and Special Needs replaced Dr. Fry on the board.

Nicole Wynkoop resigned from the SC First Steps Board of Trustees effective January 28th.

With all of the above changes the committee would like to thank all of the outgoing trustees for their service and commitment to the children of South Carolina while welcoming new trustees to the SC First Steps board and the Early Childhood Advisory Council. The Executive Committee meeting of the South Carolina First Steps Board of Trustees was called to order by David Morley at 11:05 am. Dr. Canright motioned and Dr. Williams seconded approval of the agenda as submitted. The motion carried unanimously.

Executive Director Georgia Mjartan provided the committee members on information about 2023 priority setting and planning, including key organizational "rocks" that advance the five-year strategic priorities and a calendar of key events for the year.

Director Mjartan provided the committee with a draft of the agency's legislative priorities, based upon feedback from key stakeholders gathered through 14 sessions facilitated by the external consultant Anne Sinclair. Members offered edits to the wording and framing of several agenda items. No votes were taken on this matter. Mjartan also provided the committee with updates on legislation including prefiled bills of relevance to First Steps and the Early Childhood Advisory Council. There was a discussion about how members can support legislative efforts through testimony and sharing of expertise with lawmakers. Mjartan reminded the members of the agency's budget request and shared a status update on the budget process.

Director Mjartan gave updates on non-state funding including: Preschool Development Grant B-5 (Planning Grant for 2023 Calendar Year), Pritzker Children's Initiative (two year grant for dissemination and TA related to early childhood comprehensive portals), Night to Celebrate Community (fundraising event to support local partnerships), and 2022 Year-End Appeal (information shared included total funds raised and board and staff giving). Chairman Morley suggested reaching out to the PAT network to help disseminate the offer of TA for building early childhood system portals.

A motion was made by Dr. Amy Williams and seconded by Dr. Shelley Canright to enter executive session for the purpose of a personnel matter. The motion carried unanimously. A motion to exit executive session was made by Jennifer McConnell and seconded by Dr. Shelley Canright. The motion carried unanimously. No action was taking during executive session.

Mjartan provided the results of First Steps' Annual All Team Survey including survey results, information garnered from a follow-up meaning, making session, and next steps.

First Steps has received a revised timeline proposal from the developer of their new case and program management data system. Now, state procurement will negotiate the change order on behalf of First Steps. Updates will be provided to the board once they are finalized. Next, staff announced the establishment of the Carolina Collaborative for Early Childhood Innovation, a collaboration between South Carolina First Steps and the North Carolina Partnership for Children (NCPC). This four-month intensive brings together leaders from nine Smart Start and six First Steps local partnerships to co-design a process for defining, developing, implementing, and evaluating early childhood innovation in the Carolinas. The process developed will then be applied by NCPC and First Steps to funding opportunities to support early childhood innovation in mid-2023. The meeting closed with discussion about the ongoing planning for the five-year agency evaluation (due November 1, 2024) and work being done to inform 4K marketing efforts. SUMMARY

In FY2022-23, South Carolina First Steps intends to award up to \$725,000 in Resources for Early Acceleration and Development in Youth (READY) targeted grants to local First Steps partnerships, renewable for two additional years, to increase the local partnership's capacity and infrastructure to serve more children and families in their community. Infrastructure and capacity needs were identified by applicants in six areas: staff salaries; benefits; physical office space; technology; transportation; and other.

Awards will be made in two rounds in FY2022-23. Round 1 grants were awarded to twenty partnerships at the October 2022 Board Meeting. Round 2 applications were due on January 20, 2023, and eleven were received. Each application was blind reviewed by a unique team of three reviewers (see attached process). Reviewers and other staff came together to blindly discuss each application and make recommendations for funding. Ten were recommended for funding with eight recommended to be funded as is and two to be funded with revisions. One was not recommended for funding. Below are the details of the staff recommendations.





Each application was reviewed by a unique team of three reviewers, who were external to the local partnership team (see attached process). There were five applications that were recommended to be funded with revisions that staff will work on and bring to this committee in a future action. One was not recommended for funding.

RE: Finance and Administration Report

The Finance and Administration Committee met via Zoom conference call on February 8, 2023, to receive updates from staff and to take up action items. Detailed meeting minutes are attached. The committee brings forward two action items, and the following updates.

ACTION: Revised Local Partnership Formula Allocation Model for FY 2023-24

The Committee received input from staff based on the results of the work of the Formula Allocation Task Force the Board requested during the Allocation discussion of the Board in the spring of 2022. This discussion involved two things. Revising the Local Partnership Formula Allocation Model and introducing compliance penalties for low performance.

The Committee discussed both items and presents two motions. The first involves the compliance penalties. This conceptual framework is already in place with only a few changes. The process includes Corrective Action Plans that are implemented by the Local Partnerships based on compliance issues with the statutes, bylaws, Grant Agreement, and other operating standards. These penalties would be connected to the Allocation Model only as they are assessed by the Board of Trustees. The Allocation Model would be updated when they occur, and they can occur at any time depending on the situation. The Committee discussed the draft recommendation for the conceptual procedures and guidance, motioned and voted to submit the following Motion:

<u>Motion: To approve the conceptual procedures and guidance related to Local Partnership</u> non-compliance penalties for the staff and the Board going forward.

The second motion relates to the actual Formula Allocation Model most recently revised in 2018. The recommendation from staff informed by the Task Force was to implement a model with a 3% cap on the annual population changes per county for the data. Over time each of the Local Partnerships affected would receive the total amount the original model intended but this would reduce some of the large year to year variances we have seen recently due to the American Communities Survey data variances. The Task Force received input from the Executive Directors through two Zoom meetings that allowed for all ED's to attend and participate. Of the input received, a large majority of the ED's supported the change.

After general discussion by the Committee, we introduced and voted to approve a motion to bring this item to the Board for review and approval.

The Committee makes the following Motion:

Motion: To approve the revised Formula Allocation Model for FY 2023-24.

First Steps State Office

Financial Report

2022-23: The YTD financial report was reviewed by Mr. Barnes. The organization continues to be in good financial condition. Expenditures to date are in line with projections. In addition, our donations for the year have exceeded \$106,000.

Recovery Audit

Per SC Budget Proviso, First Steps was required to conduct an audit to review 100% of payments over three years. We received confirmation that all invoices and payments during that time had no errors and were paid appropriately.

Minutes from Finance and Administration Committee Meeting

February 8, 2023

With all public notices being provided, the Zoom meeting was called to order by Tim Holt at 10:00 am.

Required Action Item: Review of Revised Formula Allocation Model for FY 2023-24

Mr. Barnes presented information from the Formula Allocation Task Force for information, review, possible motions, and approval. He reminded the Committee that the Board decided last year to hold the Formula Allocation to the same amounts as the previous year, and at that time also requested a Formula Allocation Task Force to be created to review the Allocation Model and make recommendations on changes that would reduce the possibility that issues with the Census data or margins of error would negatively impact the funding going to the Local Partnerships.

Chelsea Richard, Mark Barnes, and Max Learner met several times and reviewed the data associated with the Allocation Model. They reviewed the Census data, looked at Medicaid data and other information. They looked at several possible options that would help put guardrails around the maximum change that could occur in the funding for any specific Local Partnership. One of the goals was to ensure that no partnership either lost, or gained, at a level they would not be able to manage over the course of a year.

Once they completed their work a meeting was scheduled with the Task Force to review and discuss possible options. The staff presented two options that might help with the issue. One was to limit the population change in any single year to 3% with another option to limit it to 5%. These were discussed and other options or recommendations were requested from the Task Force. All Executive Directors of the Local Partnerships were invited to attend. There were over 30 in attendance at the first meeting.

One of the outcomes of the meeting was feedback to wait until the new American Community Survey data came out in December, and then to evaluate the options. The second Task Force meeting was held on January 25, 2023, to review the new data evaluated with the two options of 3% and 5%. There was general discussion around the options and implications. Feedback was requested after the meeting through email from all Executive Directors. 16 of the ED's responded and their results were as follows. For the 3% allocation model, which was the preferred option as it was based on the actual variance over time of the Local Partnerships that received more than \$200,000 per year, 16 responded. Of that number, 12 supported the 3% model, 1 did not support the model, 2 were neutral on the model, and 1 did not indicate a preference.

The other area for discussion was related to a draft non-compliance process for the Local Partnerships based on the current process regarding Corrective Action Plans. This process is generally already in place, this draft just clarifies it and establishes guidance for the Board, First Steps Staff and the Local Partnerships. For the question related to the non-compliance process draft, 9 were positive, 1 was against, 2 were neutral, and 4 did not express a clear opinion. After reviewing the responses and the feedback, the staff modified the non-compliance procedure based on the comments. They combined number 2 and number 3 and further defined possible outcomes. There was also guidance on when these compliance penalties could take place. This could happen anytime during the year and could be modified as many times during the year as necessary. This information would be included in the Allocation Model as it occurs.

Based on the feedback for both issues, the staff recommendation is to approve the 3% Modified Formula Allocation Model and support in concept the revised Non-compliance procedure request.

There was general discussion by the Committee.

Tim Holt motioned that "The Committee approve the conceptual procedures and guidance related to Local Partnership non-compliance penalties for the staff and the Board going forward." The motion was seconded by Jacque Curtin and received a unanimous vote.

Tim Holt motioned that "The Committee approve the revised Formula Allocation Model for FY 2023-24 and send to the Board of Trustees for review and approval." The motion was seconded by Jacque Curtin and received a unanimous vote.

The motions will go to the Board of Trustees for review and approval.

First Steps State Office

Financial Report

The YTD financial report for 2022-23 was reviewed by Mr. Barnes. SC First Steps is in good financial shape. He shared that the projected budget for FY 2022-23 is greater than \$66 Million. We are in good financial shape and are expending our funds within our budgets and projections. At this point in the year, we have expended 55% against a projected 58%. Mr. Holt asked about the change in the 4K expenditures and Mr. Barnes discussed the process and how the funds flow from SC First Steps to Manley Garvin for payments to the 4K providers and talked about how that affects the monthly expenditures. He also mentioned the new Pritzker Grant that has been added to the budget.

Mr. Barnes also mentioned the donations report showing total donations to date of over \$106,000 and the fund-raising event, A Night to Celebrate, coming up on April 20, 2023.

Recovery Audit

Per SC Provisos, the agency was required to select a vendor to complete a Recovery Audit on First Steps. The audit was started last spring and included a review of all our payments. We have recently received the results. For the 2019, 2020, and 2021 fiscal year, we had no errors on the 100% audit of our Accounts Payable invoices.

State Budget Update

SC First Steps submitted their state budget request to the Governor's Office for the upcoming 2023-24 state fiscal year. The total is almost \$9 million. The Governor recommended two of our requests for funding. They include \$455,392 in funds to cover the cost increases over the last 5 years, and \$5.2 million for the 4K Program. These would be recurring funds to cover the one-time funds received last year to implement full statewide expansion of the 4K Program. Staff presented the agency's request to the House Ways and Means Education Sub-Committee to share and discuss the request in January. As of today, the Sub-Committee approved two of our proviso requests. One to change the date on the READY proviso, and the new proviso that would study removing the agency from under the State Department of Education.

Local Partnerships

Local Partnership Update

Mr. Barnes provided an update on the Local Partnerships. He mentioned the great progress that Abbeville and Greenwood County First Steps are making. Greenwood has completed their Corrective Action Plan and is now eligible to receive new grants from First Steps. It is expected that Abbeville will be completing theirs in the next 6 weeks. There was general discussion about the Local Partnerships. Mr. Barnes will keep the Committee up to date on any changes or new information.

ESSER Update

The State Department of Education has agreed to a resolution to the ESSER changes and retroactive requirements for the grant to First Steps. We are waiting for the documents to sign so that we can move forward.

4K Program

As of January, the program has the highest number of enrollees, which is approximately 10% more than last year. He reminded the Committee that we have worked with DSS to structure the payments from the 4K Program and the Federally funded DSS Child Care voucher program for part time vouchers, when appropriate, to increase the reimbursement to cover the actual cost for the providers. With the implementation of this model, for the first time since the program has started, providers would not have to lose money to participate.

Other

With no further business to discuss, the meeting was adjourned at 9:56 am.

FORMULA FUNDING REDUCTION LEVELS

At anytime during the year a Local Partnership may come under a Corrective Action Plan (CAP). As these processes take place, there is a wide variety of possible outcomes over different periods of time. Once a Local Partnership is moved to a level where there is a financial impact, their Allocation will be impacted in that period as appropriate for the specific situation. A Local Partnership may move through multiple levels in a single year or period and the impact may occur at that time without waiting until a future period depending on the specific situation. At least two times during each year a formal review will take place that might generate a CAP, but a CAP with a financial penalty could occur at any time depending on the specific situation.

Any financial penalty would not normally be a surprise to the Local Partnership as it would be part of an ongoing CAP or other action. If there is a financial penalty accessed by the Board of Trustees, each Local Partnership is welcome to request time either in a meeting of the appropriate Committee, or of the Board of Trustees to reconsider its actions.






Increase funding for First Steps' investment in early childhood

- 3.1 State funding for early childhood programs through South Carolina First Steps is significantly increased, providing sufficient resources to ensure the school readiness of South Carolina's children most at-risk for early school failure.
- 3.2 Federal funding for South Carolina First Steps increases.
- **3.3** Private funding for South Carolina First Steps grows significantly, helping to diversify the organization's sources of funds, providing flexibility to innovate, target specific needs, and expand promising programs.
- **3.4** First Steps is recognized for good governance, transparency, continous quality improvement, administrative and fiscal excellence, and innovation in the development and administration of a unique public-private partnership model.
- 3.5 First Steps establishes itself clearly as a statewide grant-maker, funder, and intermediary, operating collaboratively with other funders and within funder networks to learn from each other, enhance impact through collective efforts, and pool resources when appropriate in order to more successfully drive positive outcomes for young children and their families in South Carolina.

Create a coordinated and family-centered early childhood system

- 4.2 Families with young children will have knowlege about and be able to access all publicly-funded programs, services and resources for which they and their children are eligible.



Countdown to Kindergarten



Ready, Set, Go! Countdown programs build relationships to support school readiness.

Countdown Family Satisfaction Survey | Summer 2022

Three out of four families report they are better prepared to support their child with kindergarten behavior expectations after participating in Countdown to Kindergarten (CTK).

The goals of CTK are to 1) increase family awareness of kindergarten expectations; 2) ensure a smooth transition to school; and 3) create a positive relationship between the family and child's school. Most families who participated in CTK during summer 2022 agree that the CTK program has met these goals.

One in three families said the CTK program is good at building relationships between the child, family, and their soon-to-be kindergarten teacher.

Families say the "one-on-one" teaching allows children to become more "comfortable" with their teacher and makes the first day of school less "stressful" or "scary."

One in three families said the CTK program is good at preparing children for kindergarten.

Over the course of six visits, children are taught skills using "fun and engaging" activities that will prepare them for kindergarten. The CTK program also introduces parents to the expectations of kindergarten and ways that parents can support their child's progress at home.

Countdown to 4K (CT4K) had a successful inaugural year.

During the summer of 2022, the Countdown program expanded to include CT4K, a program designed to support the transition to 4K for families with rising 4-year-old children. Over 8 in 10 families said that both they (82%) and their child (80%) know their 4K teacher better after participating in CT4K.

Survey Administration

The Countdown Family Satisfaction Survey was administered online to parents/caregivers of children who participated in a Countdown program during summer 2022. There were 918 families who completed the survey, of which 570 families participated in CTK and 348 families participated in CT4K.

Respondent Demographics

Over half of CTK families (59%) said this was their first child to begin kindergarten. One in two families (55%) reported that their rising kindergarten student's education was provided by a 4K program in school during the previous year. Nearly 3 in 4 CT4K families (73%) said this was their first child to begin 4K. Nearly half of families (45%) said their rising 4K student's education was provided by unpaid care from themselves or a friend/family member during the previous year. Most survey respondents were 25-44 years old (83%) and identified as Black (43%) or White (42%).





Most Countdown teachers plan to be the teacher or teaching assistant for their Countdown children in the upcoming school year.

During summer 2022, 75% of CTK teachers were kindergarten teachers, and 75% of CT4K teachers were 4K teachers. Nearly 1 in 2 CTK teachers (48%) and over 3 in 4 CT4K teachers (81%) were first time Countdown teachers.


Countdown teachers served over 1,900 children during summer 2022.

On average, CTK teachers served 6 children and CT4K children during summer 2022. Most families (70%) who participated in CTK were referred from school district programming. Over half of families who participated in CT4K were referred from school district programming, and an additional 31% of families were referred by a school screening.

Survey Administration

The Countdown Program Teacher Survey was administered online to 356 teachers who participated in a Countdown program in summer 2022. Of the participating teachers, 354 (99%) responded, and 336 indicated which Countdown program they

participated in during the summer. In summer 2022, teachers were eligible to participate in Countdown to Kindergarten (CTK), Countdown to 4K (CT4K), or both CTK & CT4K (see figure below). Teachers participated in Countdown programs in 28 counties across the state.
